This letter is in response to our conversation regarding a complaint filed on June 13, 2017 against the Natural Gas PAC (Committee) alleging that the Committee made two monetary contributions during the 2016 election to two candidates but failed to file an out of state committee report (C-5 report).

When the complaint was made, my predecessor, Gary Bauer, discussed the complaint with staff from the Washington Attorney General's office and explained that NW Natural (the Company) is a corporation doing business in Washington state and is regulated by the WUTC. As such, the Company employed a registered lobbying firm and reported all associated expenses via the "L" form reporting track. This included the questioned contributions contained in the complaint. Mr. Bauer understood at the time that the complaint had no validity since the contributions were both reported in a timely fashion and made by a corporation with an in-state nexus.

As I communicated with you during our telephone conversation, my predecessor, Gary Bauer, believed that this issue had been resolved. I now understand that this issue has not been resolved and our case is still considered open. It is the intention that this letter and the completed Form C5 (see attached) will resolve this issue.
