

COMPLAINT TO THE PUBLIC DISCLOSURE COMMISSION

RESPONDENT BRIAN V. GRIFFITH

Candidate for Director of the Pasco School District No. 1, Position 3

On May 5, 2017, Contact Privacy Inc., registered the domain name <https://www.brianforpasco.com.com/> website. See EXHIBIT 1. The web domain <https://www.brianforpasco.com.com/> is redirected to <https://brianforpasco.nationbuilder.com>. <HTTPS://www.nationbuilder.com> designed and coded the website.

EXHIBIT 2 is a copy of the website registered by Contact Privacy which is in support of Respondent Griffith's candidacy for Director of the Pasco School District No. 1, Position 3.

<HTTPS://www.contactprivacy.com/> is a domain registrant which serves to conceal the true identity of domain registrants in order to avoid publishing the information as maintained by <https://whois.icann.org>.

There is no record as to who paid for the registration, design and development of the website www.brianforpasco.com. In addition, no candidate or campaign organization reported the contributions for the registration of the website <https://www.brianforpasco.com.com/>, nor the development of its website content.

Respondent Brian V. Griffith filed for Director of the Pasco School District No. 1, Position 3, on May 19, 2017 at 3:58 pm. See EXHIBIT 3, page 1.

The website www.brianforpasco.com is listed on Respondent Griffith's C1 Report filed with the Public disclosure Commission May 23, 2017. See EXHIBIT 4. Respondent Griffith filed for Option II, Full Reporting. A primary election will be held August 1, 2017. The General Election will be held November 7, 2017.

Respondent Griffith maintains an address of 2 Rose Court, Pasco Washington 99301. Respondent Griffith maintains a telephone number of (443) 945-0144. Respondent Griffith maintains an email address of Brian@BrianforPasco.com.

On May 23, 2017, Respondent Griffith filed a C1 Report for his candidacy for Pasco School District No. 1, Position 3, eighteen (18) days after the registration of the website domain (again, see EXHIBIT 4). Respondent Griffith failed to file a C3 or C4 report.

By the failure to file and/or file forms timely with the Public Disclosure Commission, Respondent Griffith is in violation of RCW 42.17A.205, RCW 42.17A.215, RCW 42.17A.220, RCW 42.17A.235, RCW 42.17A.240, RCW 42.17A.305, and RCW 42.17A.320.

In addition, the actions enumerated herein are in direct conflict with RCW 42.17A.001 which provides in part:

It is hereby declared by the sovereign people to be the public policy of the state of Washington:

(1) That political campaign and lobbying contributions and expenditures be fully disclosed to the public and that secrecy is to be avoided.

(2) That the people have the right to expect from their elected representatives at all levels of government the utmost of integrity, honesty, and fairness in their dealings.

(3) That the people shall be assured that the private financial dealings of their public officials, and of candidates for those offices, present no conflict of interest between the public trust and private interest.
