Response to PDC Complaint #19380

To Whom It May Concern:

Please find my written response to PDC Complaint #19380 filed by Mr. Roger Lenk of Pasco, WA regarding my campaign website and domain in support of my candidacy for the Pasco School Board. Mr. Lenk asserts in his complaint that I have registered a domain name for my campaign (brianforpasco.com), created a website for my candidacy, and done so without making the proper disclosures.

The complaint is founded in a factual error that is demonstrated by the Complainant's own attached evidence. One page two of his first exhibit, the registration date of brianforpasco.com is clearly shown to be 5/20/2017; not 5/5/2017 as alleged. I have attached an additional WHOIS lookup screen shot showing the same to be true. Because this domain was registered after my declaration of candidacy and filing my C-1 with the Commission, it was not required to be reported until my first formal C-4 report due 6/12/2017. This expense, for \$12.96, was declared on the Schedule B of this report when it was filed.

Regarding the production and content on my website, this website was built using the web hosting service, NationBuilder.com. They offer a 14-day trial period that I took advantage of beginning on 5/29/2017. On 6/5/2017, I opted to begin the subscription service with NationBuilder and the first expenses associated with this charge will appear on my June C-4 report due in July. I have attached a screenshot showing NationBuilder's free trial information, too.

Thank you for the opportunity to respond to this complaint for your work monitoring and persevering our open and transparent election process in Washington.

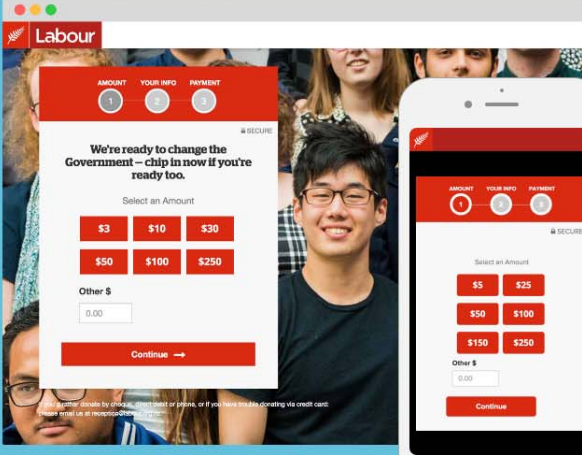
