Everyone in Wapato knows he lives at 201 Skone Way. He has even confirmed that with an email that he has sent to our City Clerk/Treasurer during one of his requests to be put on the agenda for the June 5th, 2017 Council Meeting. Mr. Orozco has always been a very problematic, complex individual.

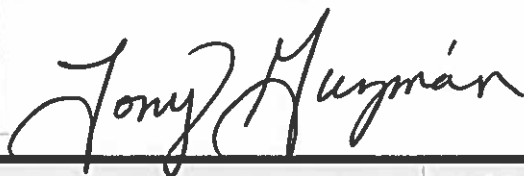
