

## File a Formal Complaint - Alex Bond

**Alex Bond** reported 40 minutes ago (Tue, 21 Feb at 10:38 AM) via Portal Meta

To whom it may concern,

I am filing a complaint against Rep. David Taylor, representative of the 15th LD and candidate for that seat in the 2016 elections.

RCW 42.17A.235 requires that political candidate committees report all contributions received to the Public Disclosure Commission (PDC).

During the entire year of 2015, Taylor reported receiving no contributions (see attached screenshot of PDC website) and filed no C3 or C4 reports.

When reviewing the expenditures of political action committees in Washington state, several PACs report having made contributions to Taylor in the year 2015. The Washington Beverage Association contributed \$950 to Taylor's campaign committee on 7/28/15, Pacific Merchant Shipping Association WA contributed \$500 on 9/11/15, WA St Association For Justice Justice For All contributed \$500 on 9/22/15, WA Restaurant Association contributed \$500 on 10/15/15, and WA St Auto Dealers PAC contributed \$500 on 9/14/15. None of these contributions were reported by Taylor's campaign. C4s from the PACs in question showing their expenditure contributing to Taylor's campaign are attached.

It's possible that other non-PAC organizations which don't report their spending to the PDC – individuals, businesses, etc - also made contributions during 2015 to Taylor that his campaign failed to report. We identified these ones because they are from PACs that themselves report expenditures to the PDC. A review of Taylor's campaign's financial records may reveal other unreported contributions.

Taylor has been in the legislature since 2009. As an experienced elected official, Taylor should be well aware of PDC reporting requirements. Furthermore, Taylor's 2016 treasurer Christina Morehead is an experienced campaign treasurer, having served in this role for his 2014 and 2012 campaigns, and she should have been personally aware of PDC reporting requirements. This failure to report cannot be explained away by unfamiliarity with the law.


