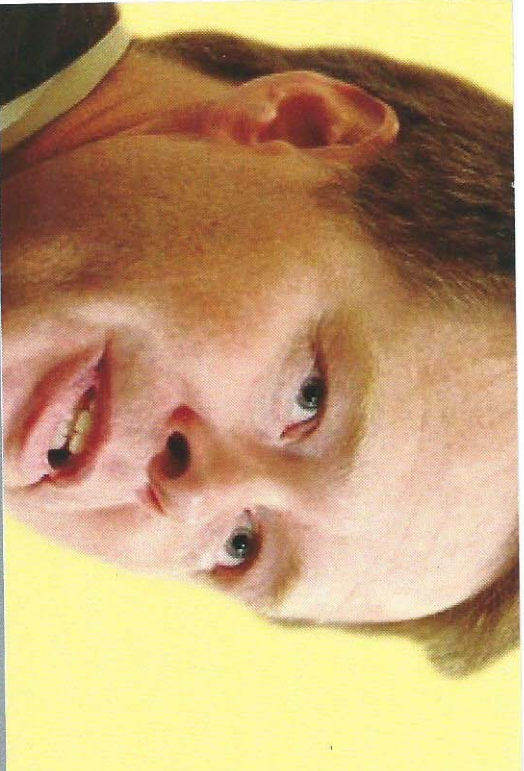




# Tim Probst slashed \$4 billion from our public schools!
