To Whom It May Concern:

This is a formal Public Disclosure Commission complaint, filed due to violations of Chapter 42.17A of the Revised Code of Washington. Mary's Pistols, a Washington corporation operating at 4040 S. Tyler St. #10A, Tacoma, Washington, 98409, along with agents or employees Rhiannon Cupps, "Dan," and "Mary," are accused of violating the following statute:

RCW 42.17A.205

Violations and Evidence

On or before September 1, 2018, Mary's Pistols began soliciting contributions for a de facto political committee. These contributions were clearly and explicitly for the purpose of purchasing radio advertising in opposition to a Washington State ballot measure, Initiative 1639.


As of September 17, 2018, a date after the legal deadline for a committee filings for committee which began collecting contributions on or before September 1, 2018, neither Mary's Pistols nor any of its officers have filed C1pc paperwork establishing a political committee (the only two committee in opposition to Initiative 1639 are a committee sponsored by the National Rifle Association established in June, 2018 and a committee managed by a local gun lobbyist established in May, 2018).

Under Washington law, Mary's Pistols, and its agents, are required to establish a committee, submit paperwork and disclosures to the Public Disclosure Commission, and be bound by specific rules for political committees. By not filing paperwork, Mary's Pistols is disregarding their obligation to the voter and people of Washington, in violation of the law.

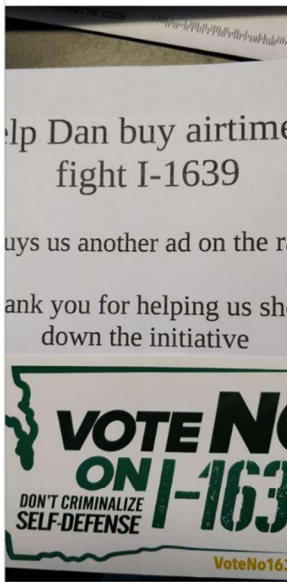

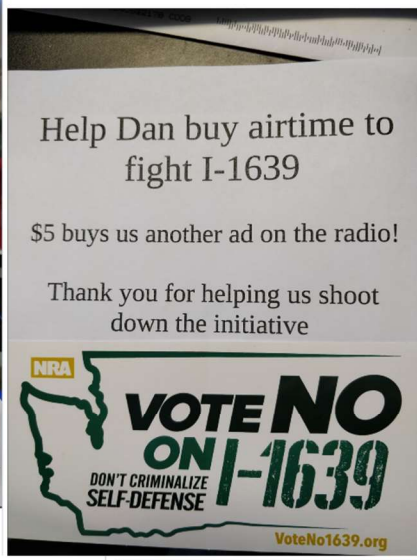
