Reachout Northwest are currently sponsoring an Initiative (collecting signatures) to change the Puyallup City Government to that of a Strong Mayor. The two pages of the initiative are attached. At the bottom of one page it says "Paid for by Reachout Northwest". At the bottom of the other it identifies an address to submit the completed forms to. 10217 128th St E, Suite D, Puyallup WA 98374. This is the private business address of Dave McMullan, Chairman of the Pierce County Republicans. His private business location is a Pest Control Company.

The reachout northwest website has no usable information. But reachout northwest has produced a youtube video identifying their political conservative agenda.
