Was there also a firewall established in 2018 between the SRCC and The Leadership Council? If yes, please describe the firewall.

Yes, as Justin Matheson indicated in his email to your office of 9/6/2018

"The complaint alleges incorrectly that Senator Braun serves on both the Senate Republican Campaign Committee (SRCC) and the WA Forward committee. This is not the case and has not been the case since well prior to the expenditures at issue in the complaint.

Senator Schoelser and Senator Braun separated from SRCC in May of 2018 and we established a firewall between SRCC and them. At our June meeting it was formally ratified that Schoelser and Braun were fully separated from SRCC and screened from any and all candidate coordination. At this same meeting Senator O'Ban's new role as Chair of the SRCC was ratified as was Sen. Hans Zeiger's addition to the SRCC.

Unfortunately, when Senator Braun left the SRCC committee an amended C-1 was not immediately filed reflecting his removal from the leadership of the SRCC. Senator Braun hasn't been involved with any activities of the SRCC since May and only remained on the outdated C-1 because of an administrative mistake. Upon realizing this mistake the C-1 was immediately amended to reflect Senator Braun's withdrawal from the SRCC. At all times relevant in the complaint the SRCC has been screened off from all activities of WA Forward and will continue to do so under our existing structure.

Did The Leadership Council provide information to WA Forward to conduct either its independent expenditures and/or electioneering communications activities during the 2018 election? How did WA Forward obtain that information?

Leadership Council didn't provide any electioneering communication concerning either targeting or messaging to WA Forward. The question misapprehends the nature of Leadership Council which provided funding to WA Forward not information.

It does not appear that WA Forward disclosed any expenditures were made or incurred or in-kind contributions received, for the overhead costs required to have been reported to run a political committee. Did the Leadership Council pay for or provide the overhead for the costs to run a political committee and engage in its activities?

The only overhead was for treasurer/compliance which WA Forward paid for itself, all expenses were used for advocacy and paid directly to DMM.
