Candidate filed for reelection on 05-14-2019. By failing to timely within 15 days file the required C1 and additionally the F1 financial disclosure filings the voters are left guessing as to who the campaign treasurer is, what contributions and expenditures have been made, where campaign funds are banked, and where campaign records may be inspected.

Candidate is aware of the PDC requirements as evidenced by his filings in 2015.
