I took a look at his PDC report to see if he had updated his PDC to reflect his actual contributions and spending. While I was initially pleased to see that his PDC filings had been updated, I was disappointed to see that he is still trying to hide how much money he has spent and received. In my complaint, I provided documentation of an online advertisement that Mr. Chan had purchased on the website nwasianweekly.com, yet looking at his C4 statements, he has not provided any documentation of making such an online purchase. I am deeply concerned by what appears to be an ongoing effort by Mr. Chan to conceal his campaign finances from the public eye, and wanted to see if there have been any updates on the investigation into my complaint? I have reattached the evidence of the online advertisement as well as Mr. Chan's two C4 reports for you to view.
