What impact does the alleged violation(s) have on the public?

The public's trust is broken if a candidate were to use campaign funds for personal use. The public has a right to know if Jay Rodne, in fact, used campaign surplus funds to pay for the registration/filing fee for PacRim Bridges LLC, a business he and WA state Senator Doug Ericksen founded, which Mr. Rodne registered with Washington's Office of the Secretary of State that shows a registration/filing date of 11/28/17.

To Whom it May Concern:

I have reason to believe that former Washington state representative Jay Rodne made an expenditure in November of 2017, using monies from his "Friends for Jay Rodne Surplus" account, for a purpose that, to my best knowledge, would be considered to be personal in nature which would appear to be in violation of WAC 390-16-238.

There may be other state statutes that I am unaware of which apply to this potential violation, but since my knowledge on Washington state campaign finance law is limited, I leave that up to your agency's expertise to further address.

According to the C4 "Cash Receipts and Expenditure" report dated 12/11/17 for the report period 11/1/17 to 11/30/17 for Jay Rodne's "Friends for Jay Rodne Surplus" account, Mr. Rodne made a \$200.00 expenditure with a "paid date" of 11/27/17. The purpose and/or description of that expense was listed as "fees for c1." I have attached a screenshot of that expense in Exhibit A accompanying this complaint. WAC 390-16-238 states, in-part:

- "(1) Except as specifically allowed by chapter 42.17A RCW, any expenditure of a candidate's campaign funds that is not directly related to the candidate's election campaign is a personal use of campaign funds prohibited under RCW 42.17A.445.
- "(2) An expenditure of a candidate's campaign funds shall be considered personal use if it fulfills or pays for any commitment, obligation or expense that would exist irrespective of the candidate's election campaign."

RCW 42.17A.430 specifically outlines the eight ways in which the surplus funds of a candidate or a candidate's authorized committee may dispose of surplus funds. One of those eight listed ways to dispose of surplus campaign funds is to hold the surplus campaign funds in a separate account for non-reimbursed public office-related expenses or as provided in RCW 42.17A.430, and report any such disposition in accordance with RCW 42.17A.20.

After reviewing those eight ways to dispose surplus campaign funds, I do not believe that the \$200.00 payment Mr. Rodne made in November of 2017 to Washington's Office of the Secretary of State (where he used funds from his "Friends for Jay Rodne Surplus" account) applies to any of those eight ways.

Also, after doing research, I do not see any other possibilities which could correlate to that \$200.00 payment made to the Office of the Secretary of State dated November 27, 2017 on the C4 report referenced above.

It's my understanding from speaking with a PDC staff person on November 14, 2019, that there are no fees associated with any candidate or PAC for filing a C1 registration form.

Also, the \$200.00 expenditure amount does not appear to be related to any potential candidate filing fee (filing week is in May) which for state legislature candidates, would be paid to

Washington's Office of the Secretary of State, because that fee amount then would have been significantly higher than \$200.00.

To the best of my abilities, I cannot find any evidence to substantiate that the purpose for Mr. Rodne's payment of \$200.00 using his "Friends for Jay Rodne Surplus" account he made to Washington's Office of the Secretary of State, was for anything related to his stated purpose which was, "fees for C1."

However, I was able to find substantiation for the possibility that Jay Rodne may have used funds from his "Friends for Jay Rodne Surplus" account to pay a \$200.00 fee to register his business, PacRim Bridges LLC, with Washington's Office of the Secretary of State.

In reviewing Mr. Rodne's \$200.00 expenditure listed on his C4 report dated 12/11/17 for the report period 11/1/17 to 11/30/17, I am cognizant of the fact that, according to records I obtained from Washington's Office of the Secretary of State, Mr. Rodne and Washington state Senator Doug Ericksen are listed as individual "Governors" of a business named PacRim Bridges LLC which was registered with the Office of the Secretary of State on November 28, 2017. According to those records, Jay Rodne is the listed registered agent for PacRim Bridges LLC. I have attached a screenshot of the registration in Exhibit A accompanying this complaint.

The public records recently released to me which I obtained from Washington's Office of the Secretary of State show there was a \$200.00 credit card payment made by Jay Rodne for the registration fee charged for registering the PacRim Bridges LLC business with the Office of the Secretary of State. I have included a screenshot of the Certificate of Formation record in Exhibit A accompanying this complaint.

Because of what I've outlined above, I believe it is possible that Jay Rodne may have used \$200.00 from his "Friends for Jay Rodne Surplus" account to pay Washington's Office of the Secretary of State for the \$200.00 registration fee for registering the PacRim Bridges LLC business in November of 2017.

I request that your agency investigate this matter to determine the purpose of that \$200.00 expenditure listed on the C4 "Cash Receipts and Expenditure" report dated 12/11/17 for the report period 11/1/17 to 11/30/17 for Jay Rodne's "Friends for Jay Rodne Surplus" account.

Former state representative Jay Rodne served multiple terms as a Washington state representative, so he certainly has had plenty of experience to give him ample understanding of campaign finance law relating to the disposition of surplus account funds.

If it turns out to be the case that the PDC finds that Mr. Rodne used funds from his "Friends for Jay Rodne Surplus" account to pay the registration fee to register PacRim Bridges LLC, a personal business he has with Senator Ericksen where presently they are registered as foreign agents doing consulting work for the Kingdom of Cambodia under an annual \$500,000 contract, I hope Mr. Rodne would then be assessed the maximum penalty/fine possible for such a violation of state law under WAC 390-16-238 and any other applicable state law.




Screenshot of Page 1 of the Certificate of Formation for Pac Rim Bridges LLC filed with Washington's Office of the Secretary of State
