

## File a Formal Complaint - Kelly Anderson

Kelly Anderson reported 6 days ago (Tue, 19 Jun at 3:21 PM) via Portal Meta

Legislative District 12 House candidate Keith Goehner has campaign signage throughout numerous locations in the 12th LD. But, he has yet to file any fundraising donations, loans or expenditures according to the PDC webpage as of today (June 19, 2018). His campaign signs have been up for several weeks. These signs either represent a donation, loan, or gift, yet Mr. Goehner has not reported any receipts of money or in-kind gifts, nor has he reported any expenditures for their purchase. Mr. Goehner filed with the PDC Mar 18, 2018 and indicated Option II Full Reporting. So far, it appears there has been no reporting whatsoever. I have attached several of Mr. Goehner's campaign signs that are in my neighborhood. These photos were taken in the Wenatchee, Entiat, and Plain area. There are many more throughout the district as well. I have seen others in the Cashmere and Leavenworth area. In addition, Mr. Goehner has a website that claims to be paid for by his campaign (see attachment). This website is actively seeking donations (<https://keithgoehner.com>) . He also is advertising an upcoming fundraiser. The ad states that it is paid for by his campaign, but there are no public records of these expenses. Campaign monies are clearly being secured and spent without being reported according to the requirements of Washington State Law. Transparency of donors, donations, loans, expenditures, etc. is public information that is not being made available to voters.
