#### **Complaint Description**

**Glen Morgan** (Thu, 29 Oct 2020 at 2:33 AM)

To whom it may concern,

It has come to my attention that Matthew Little, a candidate for the Clark County Council has violated Washington State's campaign finance laws (**RCW 42.17A**). The details of these violations are as follows:

1) Failure to accurately describe expense, and the illegal concealment of required information from the public. (Violation of RCW 42.17A.240(6), RCW 42.17A.235 & WAC 390-16-037, WAC 390-16-205)

This campaign has failed to follow Washington State's Campaign Finance laws as they apply to the reporting of expenditures.

Here are some examples that need to be corrected by this campaign to at least go through the motions of complying with the statute: On the campaign's C4 (**PDC Tracking # 101011444** see attached) dated October 26, 2020, the campaign reported expenditures of \$5,000 for "Digital" from vendor "Ravenna Strategies" but failed to legally detail how many digital ads were purchased, where they were run, and a variety of details clearly defined in **WAC 390-16-205**, a clear violation of the **law**. On another C4 (**PDC Tracking # 101006097**) dated October 13, 2020, the campaign reported expenditures of \$1,074.00 (on September 14, 2020) for "yard signs" and another \$10,050.97 on September 14, 2020 for "mailers", but, once again, this campaign failed to legally detail how many signs or mailers were purchased. **More clear violations of the law**.

More similar violations can be found on other expenditure reports (PDC **Tracking #100983102**) where most of the expenditures are lacking adequate legally required details. For example, \$1,147.96 spent at "Columbia Litho" for "printed materials." Again, no details or amounts reported. See **WAC 390-16-037**. On the same report – three different expenses dated June 29, 2020 for generic "signage" for \$325.20, \$2,500, and \$3,349.26 respectively. Again, another clear violation of **WAC 390-16-037**.

These are clear examples of a failure to provide sufficient detail of expenditures (unambiguous violations of RCW 42.17A.240(6) and WAC 390-16-037 (see example B provided at WAC 390-16-037(3)).

2. Misuse of campaign funds for personal benefit (Violation of RCW 42.17A.445, WAC 390-16-238(3)(c))

It appears this candidate has abused the political contributions he has obtained from donors and used at least some of these funds for his own personal benefit in explicit violation of **RCW 42.17A.445** and more specifically **WAC 390-16-238(3)(c).** A specific example of this violation can be found on the campaign's C4 expenditure report filed October 13, 2020 (PDC **Tracking # 101006097**). The last expenditure on this report was listed for vendor "Rapid Auto Glass" for \$259.00 on October 7, 2020. This is clearly an expenditure to repair the candidates windows on his car, which is a prohibited personal expenditure for which campaign funds can't be used (See **WAC 390-16-238(3)(C)).** 

This campaign has a professional treasurer and should be able to marginally comply (or at least go through the motions of compliance) with the statute. Every ORCA class put on by the PDC explicitly instructs those who take the class about these requirements. It is possible to comply with the law.
