he/she is speaking on his/her own behalf, and not on behalf of the agency. He may support or oppose a candidate on his own web page provided that no public resources are used.

It was recently brought to his attention there may be some controversary about him sharing his support for a candidate but since it IS his <u>personal</u> Facebook page, we didn't feel it was against any PDC rules to do so.
