To whom it may concern,

It has come to my attention that Ana Ruiz Peralta, a candidate for the Franklin County Commission has violated Washington State's campaign finance laws (**RCW 42.17A**). The details of these violations are as follows:

1) Failure to accurately describe expense, and the illegal concealment of required information from the public. (Violation of RCW 42.17A.240(6), RCW 42.17A.235 & WAC 390-16-037, WAC 390-16-205)

This campaign has failed to follow Washington State's Campaign Finance laws as they apply to the reporting of expenditures.

Here are some examples that need to be corrected by this campaign to at least go through the motions of complying with the statute: On the campaign's C4 (PDC Tracking #101011951 see attached) dated October 27, 2020, the campaign reported expenditures of \$862.88 for "Rack Cards" from vendor "The Print Guys" but failed to legally detail how many rack cards were purchased, which are clearly required and defined in WAC 390-16-037, a clear violation of the law. On another C4 (PDC Tracking # 101011311) dated October 26, 2020, the campaign reported expenditures of \$654.70 (on September 25, 2020) for "Rack cards" and once again, this campaign failed to legally provide the amounts. Same with the next expense of \$265.91 for "Yard Signs." Again no details. Even more egregiously, on the same report, this campaign spent \$3,900 for "Internet Marketing" with "Upper Left Strategies" with no details on what advertising, how many advertisements, and the breakdown of other costs incurred with this nebulous lack of a description. Specifically see WAC 390-16-205 as well as WAC 390-16-037. On the same report \$3000 was spent on "radio advertising" with "Laly, Laraza, Exitos, Lareyna" on October 10, 2020. No description of how many ads, on what stations, etc. The next item on this report was called "Political Advertisement" for \$1,256.25 with "Franklin County Graphic." Again, this is completely missing the legally required details. More clear violations of the law.

These violations basically continue on almost every expenditure report. For example on the C4 filed on September 12, 2020 (See **PDC Report # 100998289**), In addition to the usual violations with unknown numbers of "Rack Cards" for \$413.67 and "Rack Cards and Stickers for signs" for \$547.00, there are expenditures of \$1,940.00 and \$1,440.00 for "Advertising" with zero details other than random vendors. There are also reported expenses of \$3,000 for "Radio services" to "Diamante Media LLC" but no explanation for where the radio ads were run.

I've attached more C4 reports where similar violations were committed. All these reports will have to be fixed and addressed. The actual vendors who ran the ads will need to be identified for the many radio ads.

These are clear examples of a failure to provide sufficient detail of expenditures (unambiguous violations of RCW 42.17A.240(6) and WAC 390-16-037 (see example B provided at WAC 390-16-037(3)).

This campaign has a professional treasurer and should be able to marginally comply (or at least go through the motions of compliance) with the statute. Every ORCA class put on by the PDC explicitly instructs those who take the class about these requirements. It is possible to comply with the law, even if this candidate believes the law does not personally apply to them.

What impact does the alleged violation(s) have on the public?

The public has a right to know how politicians and candidates like this one spend their large campaign war chests. Concealing the number of mailers, signs, rack cards and other campaign expenditures despite a clear requirement in the law to report these details is a real problem. Even more significantly, concealing the radio ad buys, how many and on which stations is a problem. This candidate needs to just follow the law for a change.
