## **PDC Staff-generated Complaint**

#### Respondent name

Mercer Islanders for Sustainable Spending, a political committee registered with the PDC in 2019, made independent expenditures and electioneering communications in support of or opposition to a number of candidates for Mercer Island City Council during the 2019 election cycle.

### Alleged violation(s)

Based on information PDC staff became aware of during the investigation of the Federal Express (Printing and Copying Division) complaint filed in PDC Case 60811, PDC staff is completing a Staff Generated complaint alleging violations of:

- (1) RCW 42.17A.240 by failing to provide the required expenditure details for independent expenditures and electioneering communications undertaken by the PAC during the 2019 election cycle on 21-Day and 7-Day Pre-General Election Summary Full Campaign Contributions and Expenditures reports (C-4 reports), including the 2019 candidates for Mercer Island City Council supported or opposed by the expenditures, the number of mail pieces printed, and other required expenditure information.
- (2) RCW 42.17A.260 and .305 by failing to timely file Independent Expenditure reports (C-6 reports) disclosing independent expenditure and electioneering communication activities undertaken in support of or opposition to candidates for Mercer Island City Council during the 2019 election cycle.

## What impact does the alleged violation(s) have on the public?

The C-4 reports filed by Mercer Islanders for Sustainable Spending did not identify any of the 2019 candidates for Mercer Island City Council supported or opposed by the expenditure.

The four initial C-6 reports were filed one day prior to the November 5, 2019 general election, and the four additional C-6 reports were all filed after the election had been held.

The citizens of Mercer Island were deprived of critical campaign finance information concerning the independent expenditures and electioneering communications undertaken by Mercer Islanders for Sustainable Spending in support of or opposition to a number of candidates for Mercer Island City Council during the 2019 election cycle.
