Thank you for your inquire discussion and letter regarding last years candidate filing, copy of your letter enclosed. As indicated in the paperwork supplied all correspondence ended in November last year though documents show an email sent me that I did not get. So hopefully to resolve all concerns I believe due to circumstances I will demonstrate that a campaign short filing adjustment is in order so please look at the exhibits and I hope you will agree as it turns out very little money was spent.

Most all the financial concern revolves around, a print and mail flier, (documents 1 and 2) as contracted for but never delivered to 3rd Legislative District voters contracted through the company, ValPac. However ValPac needed credit card to get working and as check would take to long for mailing to have been sent timely so as a result I used a personnel credit card as evidenced in documents (3, 4, 5, 6,) showing, expenditure on my private account ending on number (4043) followed by contest letter and credit applied to next statement. So there was an intent to donate but unfortunately that did not happen so the expected contribution never actually occurred and due to circumstances beyond my control.

Further the campaign had a bank account, (7, 8) as set up with initially \$500 that was to be refunded at the end of the campaign and the lessor residue was. Documents provided show account and closing of that account after the end of the campaign.

So in the end less that a thousand-dollars was actually received or spent during the campaign. And that simply needs to be reflected in the PDC filings made so the easiest way to reflect that is likely the best but the question is now in you're court?

Mr. Apple:

After conducting a preliminary review and assessment of the PDC staff-generated complaint filed against you on March 10, 2021, concerning several alleged campaign finance violations, PDC staff has opened a formal investigation. On June 1, 2021, staff held a case status review, referred to as an initial hearing in accordance with RCW 42.17A.755, and WACs 390-37-060 and 390-37-071.

Thank you for participation by telephone at the hearing, where it was noted that the case status review is not an adjudicative proceeding. I stated during the hearing that RCW 42.17A.755 provides PDC staff with additional tools to resolve complaints through the use of alternatives to full, formal adjudication, or through referral to the Attorney General's Office. I encouraged PDC staff to work with you on resolving this matter.

As noted during the hearing, while the PDC's official form of communication is by email, you requested that you receive all correspondence concerning this matter by US Postal Service and staff agreed with your request. If you have questions, please contact Kurt Young, PDC Compliance Officer at (360) 664-8854.

Mr. Young has attached copies of the PDC staff-generated complaint for this matter, an email string between you and Kim Bradford, PDC Director of Community Outreach, and blank PDC C-3 and C-4 report forms for you to complete and mail to the PDC along with the documentation for the ValPak expenditure/reimbursement.

Mr. Apple,

We received a C-3 report from your campaign this week. We are unable to accept it without a deposit date, as that is required information. Per the letter you attached, it appears there was no deposit date because you signed the check over to a third party. Under RCW 42.17A, campaigns are prohibited from giving away active campaign funds. Candidates may donate surplus funds after the election to a charity registered with the Secretary of State. Fagan LLC does not appear to be such a charity. If you are able to recoup the contribution, one option open to you is to refund the contribution to the original contributor.

You also provided information about a vendor refund. We need a C-3 showing the receipt of the refund from Valpak. You also need to submit a C-4 showing the money received on line 2, and the vendor refund as a negative number on lines 6 and 15. Please also provide a schedule C showing the vendor refund. I have attached extra copies of the forms you will need. They are due Dec. 10.

If you repay part of your candidate loan, you can show that information on the C-4, lines 5 and 14. You also need to complete Schedule L, section 2 (loan payments). Please be aware that candidates are limited to \$6,000 in loan repayment for the general election.


