This is despite the fact that he purchased his cormanforrenton.com URL in 2017 (which he also failed to report in his 2017 campaign) which has not had any monthly charges reported ever, and his website was redesigned this year according to the copyright. His website was created using wordpress which means he either had to pay someone to create it for him or he had to pay for the platform and design it himself yet there has been no C4 report filed since 08/30/2020. Additionally, Randy has an active donate page via the Anedot platform yet he has not filed any C3 reports since 08/25/2020.</p>
What impact does the alleged violation(s) have on the public?
By failing to timely or accurately file contribution and expenditure reports Randy is depriving the public of knowing how he is spending his money, and where his money is coming from.



