During the month of July we received two mailers in support of Marty McLendon, a WA Senate candidate in the 26th LD. Both flyers were sent out by Our Olympic Communities WA, an independent expenditure PAC based in Bellevue. According to C-3's filed on 7/23 and 7/31, the only contributions received this year were used to make TV ad buys on 7/26 and 7/30, totaling 30K. Based on my research, the mailers received likely cost between 16 - 20K to produce and mail. My concern is that this PAC has not yet disclosed where those funds came from, nor reported the mailing expenditures themselves.

What impact does the alleged violation(s) have on the public?

1. Voter influence outside the scope of established WA campaign rules
2. Circumvents the right of a voter to know the source of contributions
