Findings of Fact,  
Conclusions of Law, and  
**Order Imposing Fine**

Pursuant to the brief enforcement hearing (brief adjudicative proceeding) notice sent to F Jeffrey Callender on June 25, 2021, a brief adjudicative proceeding was held on July 15, 2021, remotely from Olympia, WA by live audio and online transmission, to consider whether the Respondent violated RCW 42.17A.700 by failing to timely file a Personal Financial Affairs Statement (F-1 report) for calendar year 2020, which was due to be filed no later than April 15, 2021.

The hearing was held in accordance with Chapters 34.05 RCW, 42.17A RCW and Chapter 390-37 WAC. Commission Chair Fred Jarrett was the Presiding Officer. The Commission staff was represented by Compliance Coordinators Tabitha Townsend and Tabatha Blacksmith, and Jennifer Hansen, Political Finance Officer. The Respondent did not participate in the hearing or submit any written materials.

Having considered the evidence, the Presiding Officer finds as follows:

I. FINDINGS OF FACT

The matter involved PDC Staff's request that the Commission vacate a Final Order issued on August 12, 2021, resulting from an Initial Hearing on July 15, 2021, regarding F Jeffrey Callender, a Regent/Trustee for Bellingham Technical College. The Presiding Officer at the Brief Adjudicative Proceeding found Mr. Callender in violation of RCW 42.17A.700 by failing to timely file a Personal Financial Affairs Statement (F-1 report) for calendar year 2020, which was due to be filed no later than April 15, 2021 and imposed a civil penalty of \$250. The basis of the PDC Staffs Request for Reconsideration was information from Mr. Callender's family that he had passed away on March 12, 2021.

1. The PDC received credible information from the Respondent's spouse, Kristy, that he passed away on March 12, 2021.

## II. CONCLUSIONS OF LAW

The Commission has jurisdiction over this proceeding pursuant to Chapter 42.17 A RCW, the State campaign finance and disclosure law; Chapter 34.05 RCW, the Administrative Procedure Act; and Title 390 WAC.


## III. ORDER
