14 This matter was heard remotely by the Washington State Public Disclosure Commission
15 (Commission) on September 23, 2021, by telephonic and online streaming access. Respondent
16 requested review of the Initial Order within 21 calendar days of the order being served on him.
17 The hearing was held in accordance with Chapters 34.05 and 42.17A RCW, and Chapter 390-37
18 WAC.

19 Commissioners present both telephonically and online were Fred Jarrett, Commission
20 Chair (presiding); Nancy Isserlis, Commission Vice-Chair; Commissioner Bill Downing, and
21 Commissioner Allen Hayward. Also present both telephonically and online were Assistant
22 Attorney General John S. Meader representing the Commission, Assistant Attorney General
23 Chad Standifer, representing PDC Staff, and Jennifer Hansen, PDC Compliance Officer.
24 Respondent Scott M. Lehrman appeared on his own behalf. The proceeding was open to the
25 public as limited by Governor's Proclamation 20-28 *et seq.* and recorded.

1 The Commissioners had before them the following materials:

6 2021, for Adjudicative Proceedings on July 15, 2021;

- 10 4. Respondent's written request for review dated September 2, 2021;
- 11
- 12 5. Reconsideration Hearing Notice, PDC Case 94109, served September 15, 2021, and
13 the corrected notice served September 17, 2021.

15 I. FINDINGS OF FACT

16 The matter involves an alleged violation of RCW 42.17A.700 for failure to timely file a
17 Personal Financial Affairs Statement (F-1 Report) no later than April 15, 2021, for calendar year
18 2020.

19 1. Scott D. Lehrman served as School Director for Pasco School District 001 during
20 the calendar year 2020. His current term expires December 31, 2023. The Respondent
21 has no prior violations with the PDC.

22

23 2. Between February and May of 2021, PDC staff sent email reminders to all elected
24 and appointed officials regarding their missing F-1 reports for calendar year 2020.

1 3. On May 11, 2021, PDC staff emailed warning letters to elected and appointed
2 officials regarding their missing F-1 reports for calendar year 2020.

3
4 4. On June 25, 2021, PDC staff emailed the Respondent a hearing notice for a
5 Brief Adjudicative Proceeding (Brief Enforcement Hearing) to be held on July 15,
6 2021. The hearing notice was sent to the Respondent's email address of record.

7
8 5. At the July 15, 2021, Brief Enforcement Hearing the Respondent was found in
9 violation of RCW 42.17A.700 for failure to timely file the F-1 report no later than April
10 15, 2021, and was assessed a \$250 penalty, with \$150 suspended, consistent with WAC
11 390-37-143, the Brief Enforcement Hearing penalty schedule adopted by the
12 Commission.

13
14 6. On August 16, 2021, PDC staff served the Initial Order memorializing the
15 Commission's ruling by email to the contact email address of record.

16
17 7. Respondent filed the F-1 report covering calendar year 2020 activity on August
18 19, 2021.

19
20 8. On September 2, 2021, Respondent contacted PDC staff in writing to appeal the
21 August 16, 2021, by telephone to appeal the August 16, 2021 order based on the fact
22 that he serves in a volunteer position without pay. He also apologized for the late
23 submittal and expressed his intent to file timely in the future.

24
25 9. On September 15, 2021, PDC staff served Respondent by email with a hearing
26 notice for a September 23, 2021, Hearing on Reconsideration before the Commission,

1 along with instructions on how to participate in the hearing remotely. On September
2 17, 2021, staff served the Respondent with a corrected hearing notice to reflect the
3 appropriate agenda time.

5 **II. CONCLUSIONS OF LAW**

6 1. The Commission has jurisdiction over this proceeding pursuant to Chapter
7 42.17A RCW, the State campaign finance and disclosure law; Chapter 34.05 RCW, the
8 Administrative Procedure Act; and Title 390 WAC.
9

10 2. Pursuant to RCW 42.17A.700, an elected or appointed official who held office
11 in 2020 was required to file an F-1 report, disclosing financial information for calendar
12 year 2020, no later than April 15, 2021.
13

14 **III. ORDER**

15
16 After consideration of the mitigating and aggravating factors, including Respondent's
17 written appeal and testimony, and the Findings of Fact and the Conclusions of Law, the
18 Commission AFFIRMS the Initial Order assessing a civil penalty of \$250, with \$150 suspended,
19 for late filing of the F-1 report in violation of RCW 42.17A.700. This Order will be the Final
20 Order.
21

22 1. Respondent Scott D. Lehrman is assessed a total civil penalty of \$250, with \$150
23 suspended, on the following conditions:

11 **NOTICE: PETITION FOR JUDICIAL REVIEW**

12 You have the right to appeal this Final Order to Superior Court, pursuant to the Petition for
13 Judicial Review provisions of RCW 34.05.542. Any Petition for Judicial Review of this Final
14 Order must be filed with the court and also served upon both the Commission and the Office of
the Attorney general within thirty (30) days after the date this Final Order is served upon you.
