PDC staff:

I did not receive a response to this email or my voicemail, so I will plan to attend the hearing on Thursday. Here are the facts of my case I plan to present:

1. During 2020, I was primarily working as part of the Covid pandemic response team within the Governor's office.

2. I left public service on January 15, 2021, and acknowledge that I did not timely file a 2020 F-1 report. Any notifications or reminders associated with this obligation would have gone to my .gov.wa.gov email account, which I no longer had access to after January 15, 2021.

3. I received notice from the PDC to my personal email account on June 29, 2021. The timing of this notice was very unfortunate for me, due to my planned vacation and relocation, an unprecedented heat wave in my area, family obligations, and personal health impacts.

From June 29th through July 6, I did not have access to my financial records because they were packed into moving boxes.

From June 30 - July 11, I was on vacation / relocation leave in Central Washington, where I was moving. During this transition, I did not have access to the necessary computer equipment or internet access to complete the reporting requirement. I also suffered extreme health impacts from being six months pregnant and moving during an unprecedented heat wave (111 degrees in my area) where I lacked air conditioning. I was also focused on spending important time with family, including my parents, who I haven't seen in a year and half due to the Covid-19 pandemic.

On July 12, 2021, I filed my F-1 report online and sent an email to pdcc@pdcc.wa.gov. I also sent, via email, confirmation from my bank of a payment order to the WA State Treasurer for \$100 (to be delivered by July 19th), and a signed Statement of Understanding. Because I still lack access to a working printer, I have submitted the materials to the best of my ability electronically, with my electronic signature.

4. I served as a Washington state employee for seven years, and have never been cited for any violations during my public service.

I request that the Commission accept my Statement of Understanding and payment, along with my late F-1 Financial Disclosure Report.

I hereby acknowledge that I, _____ Lauren C. McCloy _____,
(Printed Name of Respondent) did not timely file the required Personal Financial Affairs
Statement (F-1 Report) with the Public Disclosure Commission (PDC) that was due to be filed by
April 15, 2021, disclosing personal financial information for calendar year 2020, thereby
violating RCW 42.17A.700.

I want to avoid the time and expense resulting from a Brief Adjudicative Hearing (Brief
Enforcement Hearing) before the Presiding Officer. Therefore, I am filing the F-1 Report,
completing the Statement of Understanding, and enclosing a check or money order in the
amount of \$100 for the late filed report, in lieu of a July 15, 2021 Brief Enforcement hearing
being held.

Because I was not able to access my prior F-1s, and the timing of this notice (received June 29th)
coincided with my planned vacation and relocation to a rural area in which I did not have
internet access, I did not have an opportunity to access the internet or any of my financial
records in order to file until today. Therefore, I have attached confirmation of the payment sent
directly from my bank. I understand that this will resolve all issues with the PDC regarding my
failure to timely file the F-1 Report, provided that my missing report is completed on-line, and
this signed Statement of Understanding are received by today, Monday, July 12, 2021.

I further understand that Commission staff will not be scheduling a Brief Enforcement hearing
before the Presiding Officer regarding my obligation to timely file the F-1 report that was due
by April 15, 2021.
