<u>Jim Lazar</u> (Tue, 22 Jun 2021 at 10:05 PM) The C1 registration shows FULL REPORTING. It has not yet filed a C3 or C4 report. This complaint is strictly about the absence of any reporting. The website, at https://thenewpatriotpac.com/ has a popup that it has 20,000 subscribers. The PAC has made expenditures to obtain a domain name, to create a website, and to produce some sort of newsletter to 20,000 subscribers. It is implausible that this was done at a cost of less than \$200, the threshold for initiating reporting. The PAC advertised, and I presume held, a rally on April 23, as advertised on its website. It is implausible that this was done at a cost of less than \$200, the threshold for initiating reporting.
What impact does the alleged violation(s) have on the public?
The New Patriot Political Action Committee was formed on January 8, 2021. The lack of any financial reporting, of either contributions or expenditures, denies the public access to information to which the public is entitled about the finances of this PAC.
