<p>(1 of 3)</p> <p><a href="#">Michaelfertakis</a> reported via the portal <i>(Tue, 29 Jun 2021 at 3:08 PM)</i></p> <p>According to Sanjeev Yonzon's campaign website's domain registration records, the domain was registered on 3/25/21 yet his campaign did not officially file with the PDC until 6/2/21 which is in violation of the two weeks of becoming a candidate provision since he purchased the campaign website in March. <p>(2 of 3)</p> <p><a href="#">Michaelfertakis</a> reported via the portal <i>(Tue, 29 Jun 2021 at 3:14 PM)</i></p> <p>Despite Launching his campaign on May 25th according to a Facebook post (even though he should have officially filed 4/8/21 at the latest given his campaign website was registered 3/25/21) Sanjeev has not filed a single C3 report. Sanjeev has purchased Campaign banners, t-shirts, bumper stickers, walk pieces, a website, a campaign logo, and yard signs but has not filed a single C4 with the campaign. Seeing as his first purchase was his campaign website on 3/25/21 which would have required him to file his campaign committee with the PDC on 4/8/21 at the latest (though it appears he only filed with the PDC on 6/2/21) he has missed the April, May, and June C4 due dates.

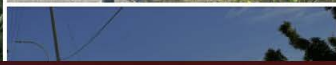
