File a Formal Complaint - Kevin VanGelder

On Aug 2nd, Richard Colwell formally requested an appointment to view the records of the Clark Leadership PAC in an email to David Gellatly and Joel Mattila for the evening of either Aug 6th or Aug 7th. He CC'd multiple people and I, along with several others, also formally requested to view the records at the same appointment.

On Aug 3rd, David Gellatly confirmed the confirmed the appointment for Aug 6th at 8PM. Since Richard Colwell's email quoted the applicable (though outdated) RCWs, David knew at the time that the 8PM appointment was both outside the RCW required hours and would not allow sufficient time for viewing the records.

On Aug 4th, Richard responded to the email chain requesting the appointment be moved to 7PM to be in compliance with our (outdated) understanding of the RCWs. At no point did David or Joel respond to or recognize this request in any manner.

On Aug 6th, Richard, Dan, Kalup, Robert, and myself showed up at the appointed location for viewing the records around 6:45PM. Around 7:00PM David and Joel arrived at the location but sat in their vehicle making phone calls, taking pictures of us, and taking pictures of some documents with us in the background. Around 7:20PM David approached us in his vehicle and told Richard he had papers for him. Richard asked if they were the records he had requested. David told Richard he had papers for him and he could take them or not but that he was leaving, at no point did he confirm or deny that the papers were or were not the requested papers.

Upon review of the paperwork, David and Joel claimed that our request was invalid because it was outside the hours required by the RCWs, which is not true because we requested to review the records the evening of Aug 6th or Aug 7th, we only ever requested a time (7PM) *after* David had already scheduled the appointment for a time after the hours required by the RCWs (8PM), and even then, that request was in good faith to help David not be in violation of our (outdated) understanding of the RCWs and they never even acknowledged our 7PM request in the first place. The documents were signed by David and Joel.

We remained at the location until 8:30PM to ensure that David wouldn't come back later and claim we had missed the original 8PM appointment. He did not return, however he did drive past the location at least two times, and likely more, until he appeared to leave the area around 7:45PM.

The 8PM appointment would have been satisfactory to us, if the records were actually available for review at that time. David either knowingly scheduled an appointment that was not in compliance with the RCWs or he found out after scheduling it that it was outside the times required by the RCWs and refused to honor the appointment he voluntarily scheduled outside the times required by the RCWs and did not reschedule the appointment at a time within the times required by the RCWs.

In my opinion, two or more of the officers of the Clark Leadership PAC conspired to prevent the voting public from lawful access to review their records as required by law, resulting in our right to review said records to be violated during the election cycle.

What impact does the alleged violation(s) have on the public?

Two or more of the PAC's officers (David Gellatly & Joel Mattila) conspired to prevent the voting public from inspecting the PAC's records as required by public disclosure law.

I certify (or declare) under penalty of perjury under the laws of the State of Washington that information provided with this complaint is true and correct to the best of my knowledge and belief.

Pursuant to:

RCW 42.17a.235(6)(a) (effective June 7, 2018): The treasurer or candidate shall maintain books of account accurately reflecting all contributions and expenditures on a current basis within five business days of receipt or expenditure. During the ten calendar days immediately preceding the date of the election the books of account shall be kept current within one business day. As specified in the committee's statement of organization filed under RCW 42.17A.205, the books of account must be open for public inspection by appointment at a place agreed upon by both the treasurer and the requestor, for inspections between 9:00 a.m. and 5:00 p.m. on any day from the tenth calendar day immediately before the election through the day immediately before the election, other than Saturday, Sunday, or a legal holiday. It is a violation of this chapter for a candidate or political committee to refuse to allow and keep an appointment for an inspection to be conducted during these authorized times and days. The appointment must be allowed at an authorized time and day for such inspections that is within forty-eight hours of the time and day that is requested for the inspection. The treasurer may provide digital access or copies of the books of account in lieu of scheduling an appointment at a designated place for inspection.

Among other deficiencies with your request, you made an open for an inspection outside the statutorily specified time allowed to inspect and therefore we are not required to open the PAC books.

Dear David Gellatly and Joel Mattila-

Under [RCW 42.17A.235](#), I am sending you notice that I want to make an appointment to view the books and other financial records you are required to maintain and make available as part of your legal responsibilities as the manager, members, and treasurer of the Political Action Committee, "Clark Leadership". There are no reports available for viewing on the PDC website for your PAC.

From the law cited above:

(4)(a) The treasurer for a candidate or a political committee shall maintain books of account accurately reflecting all contributions and expenditures on a current basis within five business days of receipt or expenditure. During the eight days immediately preceding the date of the election the books of account shall be kept current within one business day. As specified in the political committee's statement of organization filed under [RCW 42.17A.205](#), the books of account must be open for public inspection by appointment at the designated place for inspections between 8:00 a.m. and 8:00 p.m. on any day from the eighth day immediately before the election through the day immediately before the election, other than Saturday, Sunday, or a legal holiday. It is a violation of this chapter for a candidate or political committee to refuse to allow and keep an appointment for an inspection to be conducted during these authorized times and days. The appointment must be allowed at an authorized time and day for such inspections that is within twenty-four hours of the time and day that is requested for the inspection.

Additionally, according to the same law:

(6) The treasurer or candidate shall preserve books of account, bills, receipts, and all other financial records of the campaign or political committee for not less than five calendar years following the year during which the transaction occurred.

According to the paperwork you filed to form the PAC, you have designated the Clark County Republican Party as the address you will make the books available for inspection.

I would like for the appointment to be for either this Monday evening, August 6, or Tuesday evening, August 7.

My name is Richard Colwell. My telephone is 360-253-5843. However, since we are engaged in a silly lawsuit, I prefer that if you need to contact me regarding this appointment that you do so via reply to this email - I prefer all our communications be documented and protected from possible deletion.

According to the law cited above, it is a violation of this law to refuse to keep this appointment.

For those receiving this as a courtesy copy email, please consider coming to this meeting, or scheduling one of your own (read the applicable law above). It is important that you inform the PAC's managers of your name and telephone number in advance or else they may legally refuse to allow you to see the records.

This is my reason for attempting to re-set the appointment to 7 pm. The lack of response from David Gellatly and Joel Mattila is concerning to me as a citizen. I have reason to suspect they have financial transactions (donations and expenses) for which they have not submitted the proper reports as required.

In your position as the Compliance Coordinator, I would appreciate your advice not only to myself and the rest of the people attempting to view the financial records of this PAC (included in the CC list), but also to David Gellatly and Joel Mattila so that they remain fully in compliance with applicable law.
