Findings of Fact,
Conclusions of Law, and
Order Imposing Fine

Pursuant to the brief enforcement hearing (brief adjudicative proceeding) notice sent to Alexis Hlavaty dated July 14, 2021, a brief adjudicative proceeding was held on August 12, 2021, remotely from Olympia, WA by live audio and online transmission, to consider whether the Respondent violated RCW 42.17A.205 and .700 by failing to timely file a Candidate Registration (C-1 report) and a Personal Financial Affairs Statement (F-1 report) disclosing financial information for the preceding twelve months, which were due to be filed within two weeks of candidacy or no later than June 4, 2021.

The hearing was held in accordance with Chapters 34.05 RCW, 42.17A RCW and Chapter 390-37 WAC. Commissioner Fred Jarrett and Nancy Isserlis were the Presiding Officers. Commission staff were represented by Compliance Coordinators Tabitha Townsend and Tabatha Blacksmith and Jennifer Hansen, Political Finance Officer. The Respondent did not participate in the hearing or submit any written materials.

Having considered the evidence, the Presiding Officer finds as follows:

I. FINDINGS OF FACT

This matter involves PDC staff's request that the Commission Vacate an Initial Order issued on September 13, 2021, pursuant to an August 12, 2021 brief enforcement hearing wherein the Presiding Officer found that Alexis Hlavaty, former candidate for School Director of Highline School District 401, violated RCW 42.17A.205 & .700 for failure to timely file C-1 and F-1 reports that were due no later than June 4, 2021, and imposed a civil penalty of \$500 with \$200 suspended.

PDC staff's request to Vacate the Initial Order is based upon the following:

1. Alexis Hlavaty (the “Respondent”) attempted to withdraw her name from the ballot in June of 2021.
2. The Respondent submitted a *Formal Statement of Termination* form to the PDC on August 2, 2021. The form was received and processed by the PDC before the Primary Election.

II. CONCLUSIONS OF LAW

The Commission has jurisdiction over this proceeding pursuant to Chapter 42.17A RCW, the State campaign finance and disclosure law; Chapter 34.05 RCW, the Administrative Procedure Act; and Title 390 WAC.


III. ORDER
