# Allegations Supporting Alleged RCW Violations

Director Berg is acting as a political lobbyist. His actions demonstrate and reflect he has established a political action committee. He is using public school (State) property, time, and other school resources to promote and spread his purportedly private political agendas.

He is using official school board time and resources to promote his private parliamentarian business in which is business interests are integrated into his purportedly private and unofficial/personal website.

Currently Director Berg is vice-chair of the school board with the full set of ethical and moral responsibilities that entails. And now we find out he is excited and vying to take over the Chair of the SKSD Board of Directors. Another opportunity to propel is 'private' views and promotes his parliamentarian business while seated in the 'power seat' of the SKSD Board of Directors.

He is acting as a political action committee yet has not registered as one but rather relies on his candidate for office filings for funding and other actions as a smoke screen to avoid the requirement of registering the new political action committee he has formed.

He is continuing to identify with and support a registered political action committee known as Supporters of South Kitsap Schools (SSKS). While Director Berg claims that, his political actions and activities have nothing to do with his official role and duties while elected to public office (SKSD Board of Directors), he nevertheless continues to promote his 'private' website during official School Board meeting. Director Berg further claims that his website is a resource for prospective board members. There are now ten candidates for two South Kitsap School Board seats this election cycle.

He continues in full-force to lobby (invite) all and everyone who wishes access and use of his 'educational' information during official school board public meetings using both public resources and school board time while doing so.

He broadcasts and promotes his own political slant and agendas under the guise of an educational website for candidates and others in our community. He promotes and panders his political beliefs and standings during official SKSD board meetings.

He unethically invites others to devise political strategies against CSSKS as well as inviting anyone who knows any activities of Citizens Supporting South Kitsap Schools (CSSKS) such as names of members or other information to report directly to him via his political email address listed for this purpose on his website.

He professes, persists, and broadcasts his false narratives while claming his postings and actions 'are not official', with further claims that they are not representative of the South Kitsap School Board of School District.

He uses his 'private website' to contrast what he call "two opposing community groups". He lends favorable light to one, no so much to the other. It is CSSKS that is left eating 'the black cake" as they say at during police or other law enforcement gatherings. Good cop/Bad cop, so to speak. Director Berg's actions have the cast and hue of politics. His efforts are clearly aimed at attempts to pre-influence opinions on political maters as we are now beginning another political season/election cycle.

His behavior demonstrates a lack of respect and compliance with PDC rules and regulations on political activities. I will not delve into the ethical issues in this complaint. Director Berg continues to insist his private non-board representative website is politically neural.

CSSKS realizes that the role of PDC is limited in scope to address many of the above allegations and concerns. Our goal in making this letter of complaint is to ask PDC to encourage Director Berg to 'get right' with the requirements set forth in PDC rules and guidelines for lobbyists , political action committees and to abide by all relevant State Revised Codes and State Administrative Codes.

CSSKS's primary goal is to see Director Berg cease and desist from his political activities during school board meetings. We would hope he could be convinced to stop slandering and maligning any group (including CSSKS) or any individuals in our community with which he has political differences.

CSSKS believes it is reasonable to request and expect Director Berg to begin setting a proper and more appropriate example of compliance with PDC rules and regulations, especially given his status as a non-partisan elected school board official. At the very least, we hope that you can help facilitate Director Berg to follow the rules and guidelines set down by the PDC regarding his political and lobbing activities.

In response to your request for further evidence regarding allegations against SKSD Board Director J.R. Berg. Please note the evidence was submitted but you need to access the URL's to videos as well as the URL link to the respondent's website to view the evidence. The links to the evidence were labeled for each of the allegations in the complaint already submitted.

## In your reply to CSSKS on 7-8-21, you requested the following:

"Documentation of showing that Mr. Berg engaged in lobbying activities that would require him to register as a lobbyist".

**Answer:** The evidence is contained within the URL, which has video clips already submitted as the evidence you are requesting. All of the allegations being made were committed during a public meeting or meetings as well as work done on his alleged private website he claims to be using for education. He is clearly lobbying for his business during official school district meeting when referring to his private website that he promotes his parliamentarian business and qualifications.

#### In your reply to CSSKS on 7-9-21, you requested the following:

"Documentation showing that Mr. Berg engaged in activity that defines him as a "political committee"

#### **Answer:**

The evidence was previously submitted and contained when opening the URL's linking to the respondent's website. Respondent's 'private' website is where the evidence resides. The political activities he is conducting are clearly reflected on his website. His acts of working to be some sort of 'guide' and by monitoring current school board candidates compliance to PDC requirements; taking tallies of who is in compliance; asking questions and expecting responses from all of the candidates for office is clearly the actions of a quasi political action committee but still not registered with PDC as of this date.

The respondent is clearly lobbying the public to find 'dirt' on CSSKS and turn that 'dirt' into him, this also clearly reflected in compliant submitted with attachment taken from his website.
