<p><u>Glen Morgan</u> reported via the portal (<i>Mon, 12 Jul 2021 at 7:25 PM</i>)</p> <p>To whom it may concern,</p> <p>It has recently come to my attention that Krystal Marx has violated campaign disclosure laws per RCW 42.17A, during her 2017 and 2021 campaigns for the Burien City Council, once again. These violations have become habitual for this candidate. The violations she committed this time are as follows:</p> <ol style="list-style-type: none"> 1. Willfully with malice attempting to deceive and lie to the Public Disclosure Commission in a previous investigation in an effort to conceal expenditures to secretive and shady vendors (Violation of RCW 42.17A.235, RCW 42.17A.240, RCW 42.17A.750(2)(c)) <p>Last year, in a previous investigation conducted by the PDC of Krystal Marx and her violations of the campaign finance laws during her successful 2017 campaign for the Burien City Council, several concerns were raised by me (See PDC Enforcement Case #72721), but the primary concern in that investigation was complaint #1, which was titled “Attempt to conceal expenditures and vendor information from the public on campaign expenditure documents (Violation of RCW 42.17A.235, .240)” This was on the first page of the complaint I filed June 30, 2020 (see attached complaint from PDC Enforcement Case #72721 attached). The primary issue raised in that complaint was the fact that Marx was obviously concealing the incurred or paid funds to Argo Strategies, a vendor frequently referenced in PDC complaints and a known entity to the PDC.</p> <p>However, at the time, Marx claimed these expenditures did not exist (see Marx response PDC Enforcement Case #72721, dated July 16, 2020, written on Marx’s behalf by Jason Bennett of Argo Strategies claiming that only a “\$250 debt” was owed to this secretive vendor. As quoted in that same response (see Point#3) as follows:</p> <p><i>“ We have reported a debt to Argo Strategies for \$250 – that fee covers incidental reporting for our clients throughout the year. There wouldn’t be an additional expense incurred and no reporting of an additional debt to Argo would be required. Those small handful of reports would be included in that final \$250 debt owed to us. ”</i></p> <p>Unfortunately, that was a false statement made willfully, knowingly, and maliciously by the Marx campaign in collusion with their vendor to the PDC at the time. As proof this response by the Marx campaign was false, the campaign waited until after the PDC sent their final reminder in that matter (see attached) to the campaign. This secretive campaign then waited a</p>

few months, and then the Marx campaign reported the previously concealed expenditures this secretive vendor **EXACTLY** as was raised by me in the original complaint filed in **PDC Enforcement Case #72721**.

Specifically, the Marx campaign reported (See **C4 dated April 12, 2021, PDC Tracking #110016185** attached) at least \$750 of payments to this same vendor for “December 2018 treasury/compliance, January 2018 treasury/compliance, and February 2018 treasury/compliance.” These are the exact expenses which we told the PDC were concealed from the public at the time, and the Marx campaign denied existed in **PDC Enforcement Case #72721**. Yet, once the Marx campaign believed nobody was watching, they paid this secretive and shady vendor the funds for the 2017/2018 campaign in 2021.

In addition, I will draw the PDC’s attention to the \$250 debt dated the Marx C4 dated 02-12-2018 (**PDC C4 Tracking #100812344**). However, then note that on the C4 dated 03-09-2021 (**PDC C4 Tracking #110011877**) the debt has disappeared. Then on the Marx C4 dated 04-12-2021 (**PDC C4 Tracking #110016185**) Krystal Marx shows 3 payments to Argo Strategies on March 10, 2021, each \$250 for "Dec 2018 Treasury/Compliance, Jan 2018 Treasury/Compliance, Feb 2018 Treasury/Compliance " as stated previously. These appear to be 3 additional payments, not a debt repayment for the original \$250 debt. It should also be noted that the C4 dated 04-12-2021 (**PDC Tracking #110016185**) shows a payment of \$250 for the "Dec 2018 Treasury/Compliance" that was probably a typo, and should have been Dec 2017. However, how is the public supposed to know? All this is in the past, so it could be either 2017 or 2018. Which one is it?

Again, this does not erase the debt, unless it says so.

The original complaint filed last year was valid, despite the Marx/Argo Strategies false claim to the PDC stating there were no expenses during that time period. **Was Krystal Marx and her Treasurer and Argo Strategies lying to the PDC in her 07-16-2020 response, or lying to the PDC in her C4 dated 04-12-2021? Both can't be true. It is possible that they were lying in both cases** and that even more information has been concealed from the PDC at that time.

I will point out that under **RCW 42.17A.750(2)** there are specific provisions for the PDC to impose criminal penalties for willfully malicious statements and documents to be filed with the PDC in an effort to conceal their wrongdoing. **The Marx campaign, in collusion with their vendor Argo Strategies has clearly crossed this threshold of deceit in their communications with the PDC.** If they are willing to lie about issues like this, what else are they concealing from the public and what other lies are they planning to make to the PDC? We may never know, but we do know they lied about this case.

2) Failure to accurately describe expenses, and the illegal concealment of required information from the public (Violation of RCW 42.17A.240, RCW 42.17A.235)

Once I realized this candidate’s campaign was willing to violate the law so casually, I looked at the Marx 2021 campaign filings a bit closer.

The Marx campaign has failed to follow Washington State's Campaign Finance laws as they apply to the reporting of expenditures. Here is just one example:

Her 2021 campaign website is <https://www.krystal4burien.com/> (See also homepage PDF attached) At the bottom of each page of her website is this line: "©2021 by Friends of Krystal Marx. Proudly created with Wix.com" The website does not state who "paid" for the site, as required by law.

No place in her campaign C4s does Ms Marx show expenses for web hosting, web design and creation, nor the domain name reservation/renewal. Attached is a WhoIs listing, which shows the [krystal4burien.com](https://www.krystal4burien.com/) domain name was registered on 2021-02-25.

This campaign should be required to correct the record to include the information which had been willfully concealed illegally from the public. It is anyone's guess what other information this campaign has concealed from the public, and based on past experience, it appears that deception will be the first response to the PDC when PDC staff attempt to ascertain what else is missing from public disclosure.

History of Ignoring Washington State's Campaign Finance Laws

In addition to the deceit and false statements made by the Krystal Marx campaign to the PDC in regards to **PDC enforcement Case #72721** as referenced above, the Marx campaign has a long and storied history violating Washington State's campaign finance laws for many years now.

It should be noted that Councilmember Marx has been fined by the Public Disclosure Commission for previous campaign finance violations (**PDC Enforcement Case #38795** – see attached order and fine notice issued by the PDC on October 5, 2018). **Marx was fined \$250 in that instance** for failing to timely file her F1 financial disclosure documents, and apparently, according to PDC records, **it appears she refused to pay that fine and the fine was sent to collections, according to PDC records** on this case.

In addition, it should also be noted, for the record that Marx has been sent reminder letters by the PDC for her historic serial violations of the state's campaign finance laws. (See **PDC Enforcement Case#25726** – reminder letter attached where she failed to provide proper sponsorship identification on her campaign materials).

Finally, Marx has also received formal warning letters for additional violations of Washington State's Campaign Finance laws (See **PDC Enforcement Case #58190 – formal warning letter attached**) where Marx was caught attempting to conceal sources of personal income from the public on her financial affairs statements.

Marx's cavalier attitude towards the PDC reporting requirements despite the friendly and helpful reminders, formal warning letters, and micro fine imposed by the PDC in the past probably requires more explicit and tangible response by the PDC, unless there is no longer an expectation that incumbent politicians like this need to follow the law. Based on Marx's recent history, **it is clear that compliance with the law is a relatively low priority for this politician, and since there have been few consequences from violating the law in the past, last year's effort to deceive the PDC and the public does appear to be an escalation of not just ignoring the state's campaign finance laws, but now graduating to taking active steps to deceive the PDC and the public about her lawbreaking.**

At some point, with so much willful failure to follow the law and a total willingness now to deceive the PDC about her campaign finance violations, it might be time for the PDC to take more aggressive and active steps including significant fines or possible involvement of the Attorney General because clearly nothing else the PDC has done so far has made much of an impact on Krystal Marx's repetitive lawbreaking.

Feel free to let me know if you need any additional information about this one. I'm sure this is just scratching the surface.

What impact does the alleged violation(s) have on the public?

The public has a right to know when an elected political candidate lies to the PDC and attempts to conceal the truth about how they spend their campaign cash from the public. The public has a right to know how many times a politician like this can continue to cavalierly violate Washington State's campaign finance laws without consequences. The public has a right to know if the PDC is giving different treatment to different politicians, even when they obviously attempt to lie to the PDC and by extension the public.

Dear Chestine Edgar:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on October 5, 2017. Your complaint alleged that Krystal Marx may have violated RCW 42.17A.320 for failure to include Sponsor ID on political advertising.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- Krystal Marx mailed written political advertising to voters in Burien during the 2017 election, which failed to include adequate Sponsor ID, *"on the first page or fold of the written advertisement or communication in at least ten-point type."* RCW 42.17A.320(3)(a).
- In her response, Krystal Marx indicated that the address and name requirements were located on the envelope in which the advertising was mailed. This is explicitly prohibited by WAC 390-18-010(5)(a).
- Krystal Marx is a first-time candidate, with a relatively unsophisticated campaign, relatively modest contributions and expenditures, with no prior found violations of PDC requirements. WAC 390-37-061.

Based on these initial findings, staff has determined that in this instance, failure to adequately report Sponsor ID does not amount to a material violation warranting further investigation.

PDC staff is reminding Krystal Marx about the importance of properly disclosing Sponsor ID on all political advertising. PDC staff expects that Krystal Marx will comply with all disclosure requirements for political advertising in the future.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.

Below is a copy of an electronic letter sent to Glen Morgan concerning a complaint filed with the Public Disclosure Commission (PDC). As noted in the letter to Mr. Morgan, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1) and will not be conducting a more formal investigation into these allegations or taking further enforcement action in this matter.

However, pursuant to WAC 390-37-060(1)(d), this serves as a formal written warning concerning failure to comply with RCW 42.17A.710 by failing to accurately disclose financial information on your Personal Financial Affairs Statement (F-1) filed in 2019 covering 2018 activity. The Commission will consider this formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

In addition, PDC staff expects you to submit an F-1 Supplement Section C, or email a memorandum to attach to your 2019 F-1 filing, listing each donor to your GoFundMe account whose donations were used to pay for you to attend the Institute for a Democratic Future Class of 2018. The form or memorandum, due February 1, 2020, can be printed and mailed or e-mailed to the PDC. For your information, there is no dollar threshold for travel or trainings, so each donation must be listed.

Your City of Burien stipend must also be disclosed on the 2019 F-1 you file in 2020, and, in the future, you must comply with all applicable PDC statutes, rules and reporting requirements.

The alleged violations of RCW 42.17A.235 and .240 for failing to accurately and timely report contributions and expenditures are dismissed as noted in the letter below. If you have questions, contact Alice Fiman toll-free at 1-877-601-2828 or by e-mail at pdcc@pdcc.wa.gov

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed October 4, 2019. Your complaint alleged that Krystal Marx, a City of Burien council member, may have violated: (1) RCW 42.17A.710 by failing to accurately disclose personal financial information on a Personal Financial Affairs Statement (F-1) filed in 2019 for calendar year 2018 activities; and (2) RCW 42.17A.235 and .240 for failing to timely and accurately file reports of contribution and expenditure activities on Monetary Contributions (C-3) reports and Summary Full Campaign Contributions and Expenditures (C-4) reports concerning the establishment of a GoFundMe account.

To determine whether the record supports a finding of one or more violations, PDC staff reviewed: the allegations; the applicable statutes, rules, the F-1 reporting requirements; the C-1, C-3 and C-4 reports filed by Krystal Marx; and the response from Krystal Marx.

Based on staff's review, we found the following:

- Krystal Marx was elected to the Burien City Council in 2017 as a first-time candidate. She filed a Candidate Registration (C-1) for re-election to the same office on January 9, 2018 for the 2021 election year.
- As an elected official, Marx is required to file an F-1 and if needed, an F-1 Supplement report, by April 15 of each year. The report covers the prior year.
- As noted in the complaint, Marx failed to disclose Code B in the income section of the F-1 report for the \$7,200 stipend she was paid as a Burien City Councilmember on the report. In her response, Marx stated she was not aware that her city council salary was classified as income and reportable on the F-1 report.
- The F-1 report requires filers to list of income of \$2,400 or more, and based on staff's review, there were no GoFundMe with donors of \$2,400 or more.
- Based on staff's review, the GoFundMe proceeds received by Marx that were used to pay for her participation in IDF were required to have been disclosed on an F-1 Supplement Section C. Section C requires the filer to disclosed funds for official office related activities concerning: 1) Food and beverages costing over \$50 per occasion, excluding certain receptions as defined in WAC 390-20-020A; 2) Travel occasions; or 3) Seminars, educational programs or other training, "if a source other than your own governmental agency paid for or otherwise provided all or a portion" of the costs.

- Concerning the GoFundMe account, Marx stated that she requested donations to the account to pay for her to participate in the Institute for a Democratic Future Class of 2018 as a leadership fellowship. The Institute for a Democratic Future (IDF) was formed in 1997 by co-founders Dean Nielsen and Lisa Witter, “to develop and promote emerging generations of Democratic and civic leaders in Washington State,” and involves a six-month fellowship plus a week in Washington, D.C.

Staff requires Marx, by February 1, 2020, file an F-1 Supplement and complete Section C, or email a memorandum to attach to her 2018 F-1 report, listing each donor to her GoFundMe account whose donations were used to pay for her to attend the Institute for a Democratic Future.

Based on these findings staff has determined that, in this instance, failure to accurately disclose personal financial information on the F-1 report filed in 2019 covering 2018 activity does not amount to a finding of a violation that warrants further investigation.

Pursuant to WAC 390-37-060(1)(d), however, Krystal Marx will receive a formal written warning concerning her failure to accurately disclose personal financial information on the F-1 report filed for calendar year 2018. The formal written warning will include staff’s expectation Marx will disclose her City of Burien stipend earned in calendar year 2019 on the F-1 filed in 2020, and, in the future, she must comply with all applicable PDC statutes, rules and reporting requirements.

The Commission will consider the formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).

Thank you for the opportunity to respond to another complaint by Glen Morgan (#72721). Please see my responses to the claims below.

1. When Argo Strategies clients sign with us, we offer to them, included in the cost of our services, free use of our PO Box. We have cleared this with the Public Disclosure Commission several times over the years and the advice we've received is that if this is something that is offered to every Argo client (it is) then it is not reportable. If the advice of the PDC has changed, please let us know so we can immediately remedy this to match updated PDC advice.
2. If the PDC requires us to list the specific consultant at Argo Strategies assigned to the race for 2021 (that hasn't yet been determined) we will amend the report. We planned to amend next year when that was assigned.
3. We have reported a debt to Argo Strategies for \$250 – that fee covers incidental reporting for our clients throughout the year. There wouldn't be an additional expense incurred and no reporting of an additional debt to Argo would be required. Those small handful of reports would be included in that final \$250 debt owed to us. If transactions exceeded a certain level, we would incur another \$250 debt but we have not reached that threshold yet.

Thank you for your time and attention to this. We would appreciate your dismissing this complaint as we believe it is baseless and doesn't not contain any actual violations of law.

<p>Glen Morgan reported via the portal 15 hours ago (Tue, 30 Jun 2020 at 10:14 PM)</p> <p>To whom it may concern,</p> <p>It has come to my attention that Krystal Marx (consistent with past behavior) has violated Washington State's campaign finance laws once again (RCW 42.17A). The details of these violations are as follows:</p> <p>1) Attempt to conceal expenditures and vendor information from the public on campaign expenditure documents (Violation of RCW 42.17A.235, .240)</p> <p>In the 2017 General Election Krystal Marx was elected to the Burien City Council, Position 7. In January 2018 she registered to run in 2021 for the same position on the City Council, using the same campaign treasurer, but a new campaign address, which is PO Box 9100 in Seattle. This PO Box is also used by Argo Strategies. (See attached screenshot from their website.)</p> <p>Since January 2018 the Marx campaign has filed some C3 and C4 reports, the last one being June of 2018. However, no reports have been filed to account for the cost of the PO Box, or any payments to her treasurer. Either she is paying for that PO Box, or her Treasurer is providing it to her campaign, in which case it should have been reported as an in-kind contribution. Thus, she has either failed to report a PO Box expense or perhaps failed to report an in-kind contribution. (See PDC Report #100807490 as example of the mailbox address, which should be a reported campaign expenditure for the past few years). Please note, this is a clear campaign expenditure as defined in RCW 42.17A.005(22), and the PDC has upheld in the past that expenditures for a Post Office Box like this is a campaign expenditure.</p> <p>During Marx's 2017 campaign she made frequent payments to Argo Strategies for expenses and "Treasury" services, yet for all the reports filed for her 2021 campaign to date, there have been no payments reported to Argo Strategies. Again, either Marx is making payments and not reporting them, or Argo Strategies is doing this work as in-kind contributions, which are also not reported.</p> <p>2) Attempt to conceal the identities of campaign officers from the public (Violation of RCW 42.17A.205(2)(c))</p> <p>The Marx C1 (see attached) lists "Argo Strategies, Consultant" rather than the "name, title and address" of "Committee Officers and other persons who authorize expenditures." This is not a "name" and thus does not identify which employees,</p>

how many employees, and if the identity of the employees has changed over the past few years at Argo Strategies who have been authorized to approve expenditures, or act as a committee officer for this campaign.

3) Misuse of public resources to promote a political campaign (Violation of RCW 42.17A.555)

While Marx has an extensive and colorful history of violating the state's campaign finance laws, this is the first time I've been able to document that Marx is misusing City of Burien resources to promote her political campaign. Specifically, it appears that Marx is using her City of Burien email address on her Financial Affairs Statement rather than her campaign email address. As both the PDC and previous decisions by Washington State courts have concluded multiple times in the past, it is a clear violation of **RCW 42.17A.555** to use government issued email addresses as part of any political campaign, yet according to Marx's 2020 F1 (see attached) it appears Marx is breaking this law as well. This is correctable behavior.

History of Ignoring Washington State's Campaign Finance Laws

In addition, it should also be noted, for the record that Marx has been sent reminder letters by the PDC for her historic serial violations of the state's campaign finance laws. (See **PDC Enforcement Case#25726** – reminder letter attached where she failed to provide proper sponsorship identification on her campaign materials).

Finally, Marx has also received formal warning letters for additional violations of Washington State's Campaign Finance laws (See **PDC Enforcement Case #58190** – formal warning letter attached) where Marx was caught attempting to conceal sources of personal income from the public on her financial affairs statements.

Marx's cavalier attitude towards the PDC reporting requirements despite the friendly and helpful reminders, formal warning letters, and micro fine imposed by the PDC in the past probably requires more explicit and tangible response by the PDC, unless there is no longer an expectation that incumbent politicians like this need to follow the law. Based on Marx's recent history, it is clear that compliance with the law is a relatively low priority for this politician.

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on October 5, 2017. Your complaint alleged that Krystal Marx may have violated RCW 42.17A.320 for failure to include Sponsor ID on political advertising.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- Krystal Marx mailed written political advertising to voters in Burien during the 2017 election, which failed to include adequate Sponsor ID, *"on the first page or fold of the written advertisement or communication in at least ten-point type."* RCW 42.17A.320(3)(a).
- In her response, Krystal Marx indicated that the address and name requirements were located on the envelope in which the advertising was mailed. This is explicitly prohibited by WAC 390-18-010(5)(a).
- Krystal Marx is a first-time candidate, with a relatively unsophisticated campaign, relatively modest contributions and expenditures, with no prior found violations of PDC requirements. WAC 390-37-061.

Based on these initial findings, staff has determined that in this instance, failure to adequately report Sponsor ID does not amount to a material violation warranting further investigation.

PDC staff is reminding Krystal Marx about the importance of properly disclosing Sponsor ID on all political advertising. PDC staff expects that Krystal Marx will comply with all disclosure requirements for political advertising in the future.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed October 4, 2019. Your complaint alleged that Krystal Marx, a City of Burien council member, may have violated: (1) RCW 42.17A.710 by failing to accurately disclose personal financial information on a Personal Financial Affairs Statement (F-1) filed in 2019 for calendar year 2018 activities; and (2) RCW 42.17A.235 and .240 for failing to timely and accurately file reports of contribution and expenditure activities on Monetary Contributions (C-3) reports and Summary Full Campaign Contributions and Expenditures (C-4) reports concerning the establishment of a GoFundMe account.

To determine whether the record supports a finding of one or more violations, PDC staff reviewed: the allegations; the applicable statutes, rules, the F-1 reporting requirements; the C-1, C-3 and C-4 reports filed by Krystal Marx; and the response from Krystal Marx.

Based on staff's review, we found the following:

- Krystal Marx was elected to the Burien City Council in 2017 as a first-time candidate. She filed a Candidate Registration (C-1) for re-election to the same office on January 9, 2018 for the 2021 election year.
- As an elected official, Marx is required to file an F-1 and if needed, an F-1 Supplement report, by April 15 of each year. The report covers the prior year.
- As noted in the complaint, Marx failed to disclose Code B in the income section of the F-1 report for the \$7,200 stipend she was paid as a Burien City Councilmember on the report. In her response, Marx stated she was not aware that her city council salary was classified as income and reportable on the F-1 report.
- The F-1 report requires filers to list of income of \$2,400 or more, and based on staff's review, there were no GoFundMe with donors of \$2,400 or more.
- Based on staff's review, the GoFundMe proceeds received by Marx that were used to pay for her participation in IDF were required to have been disclosed on an F-1 Supplement Section C. Section C requires the filer to disclosed funds for official office related activities concerning: 1) Food and beverages costing over \$50 per occasion, excluding certain receptions as defined in WAC 390-20-020A; 2) Travel occasions; or 3) Seminars, educational programs or other training, "if a source other than your own governmental agency paid for or otherwise provided all or a portion" of the costs.

- Concerning the GoFundMe account, Marx stated that she requested donations to the account to pay for her to participate in the Institute for a Democratic Future Class of 2018 as a leadership fellowship. The Institute for a Democratic Future (IDF) was formed in 1997 by co-founders Dean Nielsen and Lisa Witter, “to develop and promote emerging generations of Democratic and civic leaders in Washington State,” and involves a six-month fellowship plus a week in Washington, D.C.

Staff requires Marx, by February 1, 2020, file an F-1 Supplement and complete Section C, or email a memorandum to attach to her 2018 F-1 report, listing each donor to her GoFundMe account whose donations were used to pay for her to attend the Institute for a Democratic Future.

Based on these findings staff has determined that, in this instance, failure to accurately disclose personal financial information on the F-1 report filed in 2019 covering 2018 activity does not amount to a finding of a violation that warrants further investigation.

Pursuant to WAC 390-37-060(1)(d), however, Krystal Marx will receive a formal written warning concerning her failure to accurately disclose personal financial information on the F-1 report filed for calendar year 2018. The formal written warning will include staff’s expectation Marx will disclose her City of Burien stipend earned in calendar year 2019 on the F-1 filed in 2020, and, in the future, she must comply with all applicable PDC statutes, rules and reporting requirements.

The Commission will consider the formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).

Pursuant to the brief enforcement hearing (brief adjudicative proceeding) notice sent to KRYSTAL MARX on August 16, 2018, A brief adjudicative proceeding was held on September 24, 2018, in Room 206, Evergreen Plaza Building, 711 Capitol Way, Olympia, Washington, to consider whether the Respondent violated RCW 42.17A.700 by failing to file a Personal Financial Affairs Statement (F-1 report) as an incumbent official, which was due to be filed not later than April 16, 2018, disclosing financial activities for calendar year 2017.

The hearing was held in accordance with Chapters 34.05 RCW and 42.17A RCW and Chapter 390-37 WAC. Commission Chair Anne Levinson was the Presiding Officer. The Commission staff was represented by Fox Blackhorn-Delph, Compliance Coordinator. The Respondent did not participate in the hearing or submit any written materials.

Having considered the evidence, the Presiding Officer finds as follows:

FINDINGS OF FACT

1. The Respondent is a candidate for CITY COUNCIL MEMBER of CITY OF BURIEN.
2. As a candidate for election, the Respondent was required to file an F-1 report by April 16, 2018.
3. The Respondent did not file the missing F-1 report prior to the date of the hearing.
4. The Respondent has no prior violations.

CONCLUSIONS OF LAW

Based on the above facts, as a matter of law, the Presiding Officer concludes as follows:

1. This matter was duly and properly convened and all jurisdictional, substantive, and procedural requirements have been satisfied.
2. The Respondent violated RCW 42.17A.700 by failing to file the F-1 report by April 16, 2018.

ORDER

ON the basis of the foregoing Findings of Fact and Conclusions of Law,

IT IS HEREBY ORDERED that the Respondent is assessed a civil penalty of \$250, in accordance with the F-1 penalty schedule set forth in WAC 390-37-143, payable within 30 days of the date of the Order.

It is further ordered that the Respondent:

1. **Pay the \$250 civil penalty within 30 days of the date of this Order.**
2. **“Cease and desist” from failing to file the required PDC reports in accordance with RCW 42.17A.755(4).**
3. **File the missing F-1 report disclosing financial activity for calendar year 2017 within 30 days of the date of this Order.**


In the event the Respondent fails to pay the \$250 civil penalty within 30 days of the date of the Order, PDC staff is directed to refer the matter to the Department of Enterprise Services (DES) for collection of the amount owed.

The matter would then be scheduled for consideration and disposition at the next Commission meeting at which it is practicable to do so.

A Respondent does not need to pay a penalty until after the Commission rules on a request for review of an initial order.

FURTHER APPEAL RIGHTS – SUPERIOR COURT

If the Commission does not receive a request for review of this initial order within twenty-one (21) calendar days, the initial order shall be the final order. *See* WAC 390-37-142(5).

YOU HAVE THE RIGHT TO APPEAL A FINAL ORDER TO SUPERIOR COURT, PURSUANT TO THE PETITION FOR JUDICIAL REVIEW PROVISIONS OF RCW 34.05.552.

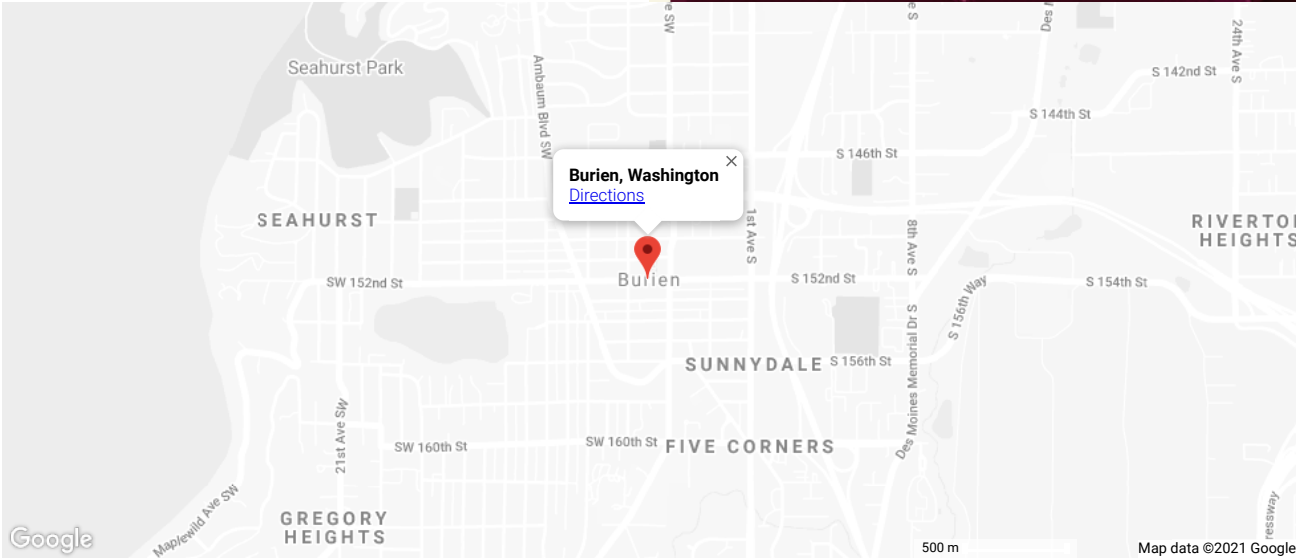
