Glen Morgan reported via the portal (Mon, 12 Jul 2021 at 9:35 PM)

To whom it may concern,

It has recently come to my attention that Jim Ferrell has violated campaign disclosure laws per **RCW 42.17A**, during his 2017 and 2021 campaigns for Federal Way City Mayor. The violations are as follows:

Please note, I had discovered a city council candidate had violated these laws, and this led me to look at some of the other incumbent councilmembers and challengers in this city, and it appears that violating the law can indeed be contagious. It is a mystery as to why this contagion seems to spread faster than the Coronavirus, but I can only report on my observations.

1. Theft or misappropriation of campaign funds for personal use (Violation of RCW 42.17A.445, WAC 390-16-238, also, due to the nature of this very serious violation – please reference RCW 42.17A.750, and .755)

On Ferrell's last C4 for his successful 2017 campaign for the same office (see **PDC C4** # **100808588 dated 01-11-2018**) he showed a closing balance of \$12,728.50, yet on his beginning C4 for his 2021 campaign (see **PDC C4 # 100997645 dated 09-10-2020**) he shows zero (\$0) for "Previous total cash and in-kind contributions". What happened to nearly \$13K from his prior campaign? Both C4s are attached for reference.

One item of note is that the C4 filed in January of 2018 is the last C4 filed by this candidate when he reportedly had an outside treasurer named Joseph Atkinson. The new C4 filed for his 2021 campaign lists the candidate as his own treasurer. Shortly after he filed the first C4 for his 2021 campaign, the candidate then went back into the 2017 campaign and made many changes to C4s. This includes a final change to the last C4 filed for his 2017 campaign which was "amended" by a C4 filed years after the campaign ended on October 22, 2020 (See **PDC C4** # **101009655**). This new "amended" C4 claims that only \$1,187.00 was left in the 2017 account.

Regardless of which C4 was accurate – whether the last one filed by treasurer Joseph Atkinson contemporaneously in 2018, or the modified "amended" C4s filed by Ferrell himself years later, money has disappeared and has yet to be accounted for by the Ferrell campaign.

The only way the PDC can verify what has transpired in this political campaign over the past few years would be to subpoen the bank records for this political committee and compare the totals to the C4 data on a monthly basis and see what the heck happened. Either the previous treasurer Joseph Atkinson concealed the truth, or Ferrell modified the C4s years later to conceal the truth. Regardless, in either case, money is missing and has yet to be accounted for, based on either set of C4s the PDC finds is most accurate.

Due to the size of missing or misappropriated campaign funds which apparently have illegally been used by the candidate, I have referenced both **RCW 42.17A.750 and .755** for reference due to the potential criminal level of activity this violation may have become (if the higher amount of \$13k is missing or some other amount more than \$5k).

This just seems weird and strange. These are large municipal campaigns, and raising Big Bucks for a municipal race is a real accomplishment. It doesn't seem like too much to ask for the financial reporting to be semi-accurate and for money to not go "missing."

2. Failure to accurately describe expenses, and the illegal concealment of required information from the public (Violation of RCW 42.17A.240(6), RCW 42.17A.235, and WAC 390-16-037, and WAC 390-16-205)

This campaign has also failed to follow Washington State's Campaign Finance laws as they apply to the reporting of expenditures. Here are some examples that need to be corrected by this campaign to at least go through the motions of complying with the statute: On the campaign's C4 (**PDC Tracking # 110016382** see attached) dated 4/12/2021, the campaign reported expenditures of \$1,401.55 for "Signs" from vendor "Capital City Press" but failed to legally detail how many campaign signs were purchased, which are clearly required and defined in **WAC 390-16-037**, a clear violation of the law. On that same C4, this campaign also reported purchases of \$1,827 for "Signs and stakes" as well as \$2,395 for "door hangers" from vendor "NWP Consulting" with no legally required details provided for any of these expenditures.

On another C4 (**PDC Tracking # 110019972**) **dated 5/10/2021**, the campaign reported additional expenditures totaling \$2000 from vendor "Fastsigns" as "in-kind" contributions which also lacked the legally required details as specified in **RCW 42.17A.240(6)**.

This campaign should be required to correct the record to include the information which had been willfully concealed illegally from the public.

The biggest concern here is the substantial missing funds from the 2017 campaign, and to see it vanish with no documentation is not typical and clearly illegal.

Feel free to let me know if you need any additional information about this one.

This mayor has been threatening to fine and harass people in his community who dare to clean up homeless junkie camp garbage, but perhaps he needs to clean up his own house first.
