<p><u>Glen Morgan</u> reported via the portal (<i>Mon, 12 Jul 2021 at 10:30 PM</i>)</p> <p>To whom it may concern,</p> <p>It has recently come to my attention that Renae Seam has violated campaign disclosure laws per RCW 42.17A, during her 2021 campaigns for Federal Way City Council. The violations are as follows:</p> <ol style="list-style-type: none">1. The illegal concealment of required information from the public, failure to report expenditures (Violation of RCW 42.17A.240, RCW 42.17A.235) <p>It appears that this campaign has failed to report the expenditure for signs on their C4s. These signs have been posted all over Federal Way for some time now, and the lack of reporting is a concern.
