<b>Complaint Description</b>
<p><u><a href="#">Jack Sorensen</a></u>  (Wed, 6 Oct 2021 at 6:15 PM)</p> <p>Pam Orebaugh and Rob Linebarger – two candidates for the Central Valley School District Board, located in Spokane Valley, WA – have created a 501(c)3 organization called “Washington Citizens for Liberty” (UBI 604 796 427, citizens4liberty.org). The nonprofit organization appears to have been formed for the purpose of collecting donations and making independent expenditures in the school board races, including for Pam Orebaugh herself, who is running for CVSD Board Position 5, and is listed on the initial board of directors for the nonprofit in the Articles of Incorporation, attached as Exhibit E. However, there is no information on file with the PDC for any contributions, IEs, incidentals, or any other campaign activities reported by Washington Citizens for Liberty.</p> <p>Exhibit A, attached, shows a Washington Citizens for Liberty sponsored piece of campaign literature advocating support for Orebaugh and another school board candidate, Bret Howell. The back of the literature, attached as Exhibit B, includes written advocacy for both candidates as well as a mission statement for the nonprofit, which clearly communicates that the nonprofit exists to assist in these elections and advocates voting for the two endorsed candidates.</p> <p>There is no question that the nonprofit was created for the purpose of electioneering. Attached as Exhibit C is a fundraising email sent by Pam Orebaugh – candidate for Position 5 – soliciting tax-deductible donations to the nonprofit (where she sits on the board of directors) from campaign supporters as an explicit means of supporting both her and Howell’s campaigns. The request can be found on page two of Exhibit C. In the final paragraph of the fundraising email, Orebaugh also details how her nonprofit is engaging in assistance with her campaign, including voter contact, yard sign distribution, and print advertising and campaign handouts – at least several activities that would require reporting to the PDC.</p> <p>Finally, attached as Exhibit D, is a screenshot of digital advertising created by Washington Citizens for Liberty and shared on Facebook expressing support for their endorsed candidates – Orebaugh and Howell.</p> <p>To reiterate: despite the fact that, as a nonprofit, they are engaging in political fundraising and election expenditures, Washington Citizens for Liberty (1) is not registered as a committee with the PDC, and (2) has therefore not filed required contribution or expenditure reports with the PDC. Setting aside the questionable purpose of the nonprofit, as a nonprofit engaged in electioneering they, at the very least, (1) have not included required contributor or sponsor disclosures on their print or digital campaign materials, (2) have not reported their material contributions to Orebaugh and Howell’s campaigns though, given the fact that one of the candidates in question is a director of the nonprofit herself, they would certainly meet the criteria of RCW 42.17A.310(1), and (3) have not filed advertising reports pursuant with RCW 42.17A.260.</p>
<b>What impact does the alleged violation(s) have on the public?</b>
<p>Allowing a nonprofit, run by a candidate, to solicit tax-deductible donations as a means of supporting her candidate while the nonprofit engages in direct spending in support of political campaigns without reporting anything to the PDC or following proper disclosure requirements undermines the integrity of Washington state elections, and the enforcement of campaign finance regulations under the PDC.</p>

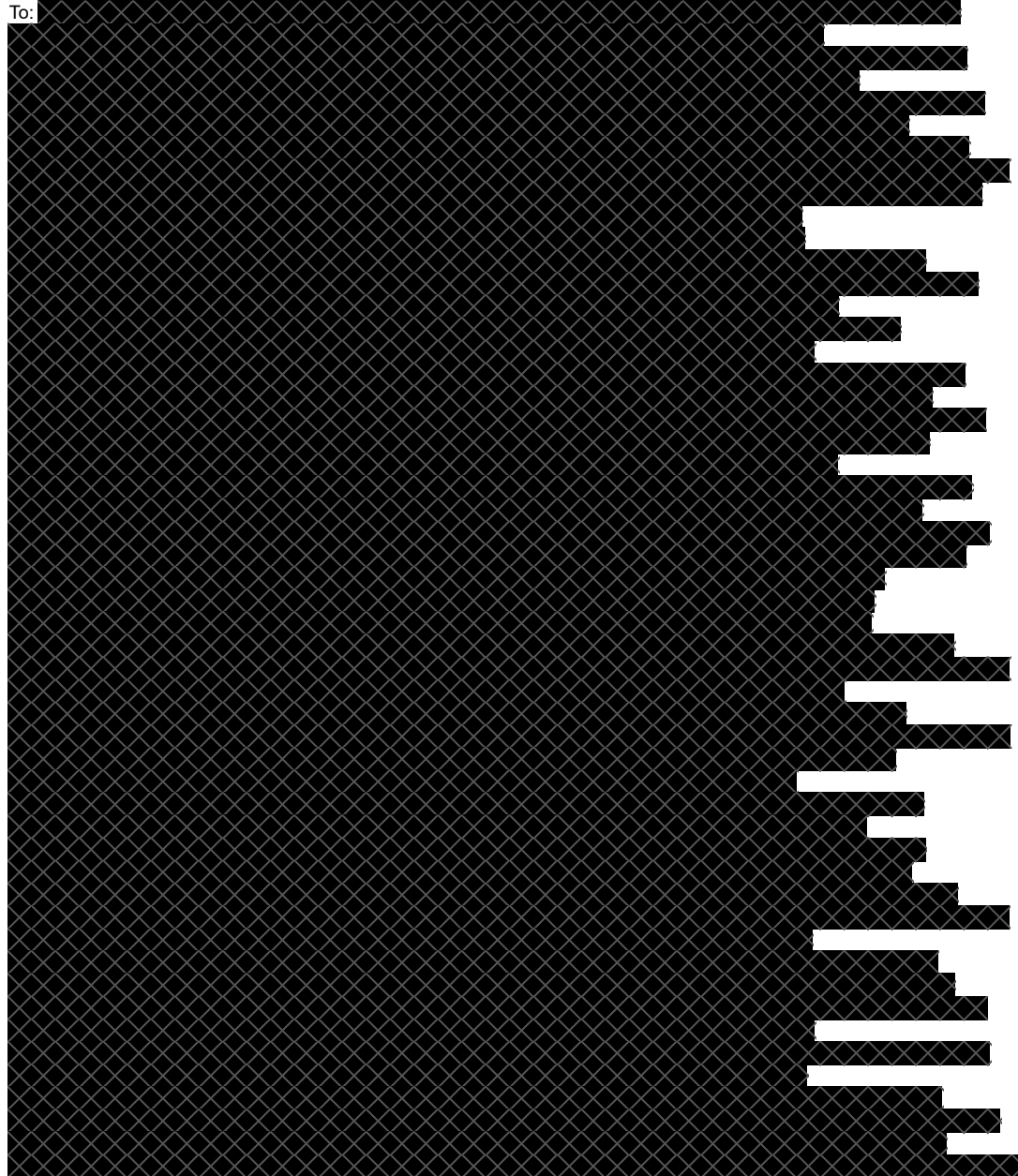

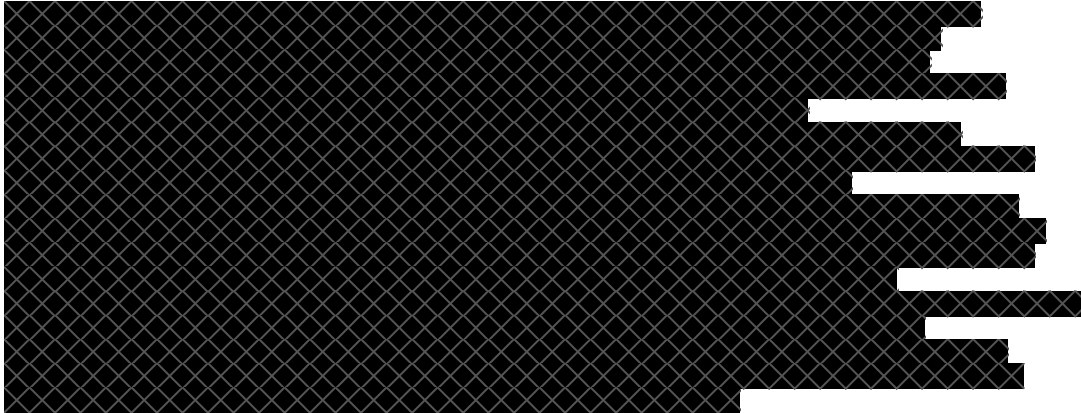

Hi all,

I am emailing with the sincerest of heart in asking for help. We need volunteers. We need donations. I appreciate those that are helping and donating. I appreciate those of you showing up for meetings and spreading the word on social media and to your friends. This also needs to continue. However, we are in danger of this all coming to a halt if we do not get help and money. I'm not using a scare tactic to get money and help but rather speaking truth.

Rob presented a clear flow chart last night of volunteers needed to gather signatures and tell voters about Bret and me. We need all levels of volunteers. I get it that we are all busy. Trust me....my schedule is insane. Rob is even busier. Everybody stepping up is busy. This is just for a season. But it is an important season. It is just for a time that we need help and money. What can you give us for time or money? What can you give up on a Saturday (or another day/evening) to help? What can you give up in money to help? A couple hours of going door to door is huge. A 5- or 10-dollar donation helps. One sign and metal stand is about 5.00. Flyers range depending on how many we purchase (from 10 cents to 2.00). Lawyers are about 200 an hour. Every little amount will help us significantly. We have been fortunate that we have gotten this far without asking for donations. However, we need them to continue much further. I have Venmo and PayPal on my website (PayPal take 3%, Venmo is free to me). Bret has ability on his website now to collect donations. The non-profit site can take donations. I can meet you to get cash or checks. I have a PO Box for my campaign and one is coming soon for the non-profit if mail works better for you.

<p><u><a href="#">Bryan Taylor</a></u>  <i>(Thu, 30 Sep 2021 at 9:16 PM)</i></p> <p>On Friday, September 24, 2021 an individual walked through my neighborhood distributing flyers to people's front doors (I live in the River District of Liberty Lake, WA 99016). The Flyer (attached) appears to be a political advertisement for Pam Orebaugh and Bret Howell, both running for Central Valley School District Board Positions 5 and 2 , respectively. The Flyer appears to show the nonprofit, Washington Citizens for Liberty and the organization, CVSD Parent's Coalition, supporting the two candidates but it does not indicate who paid for the flyer or the address of the sponsoring party. The flyer appears to be professionally printed, as it is on glossy card stock. Not including who paid for the flyer violates RCW 42.17A.320, which says, "(1) All written political advertising, whether relating to candidates or ballot propositions, shall include the sponsor's name and address." Additionally, the flyer does not appear to qualify for any of the exemptions outlined in RCW 42.17A.320.</p>
<b>What impact does the alleged violation(s) have on the public?</b>
The public is unaware of who sponsored the printing of the material being delivered to voter's homes.

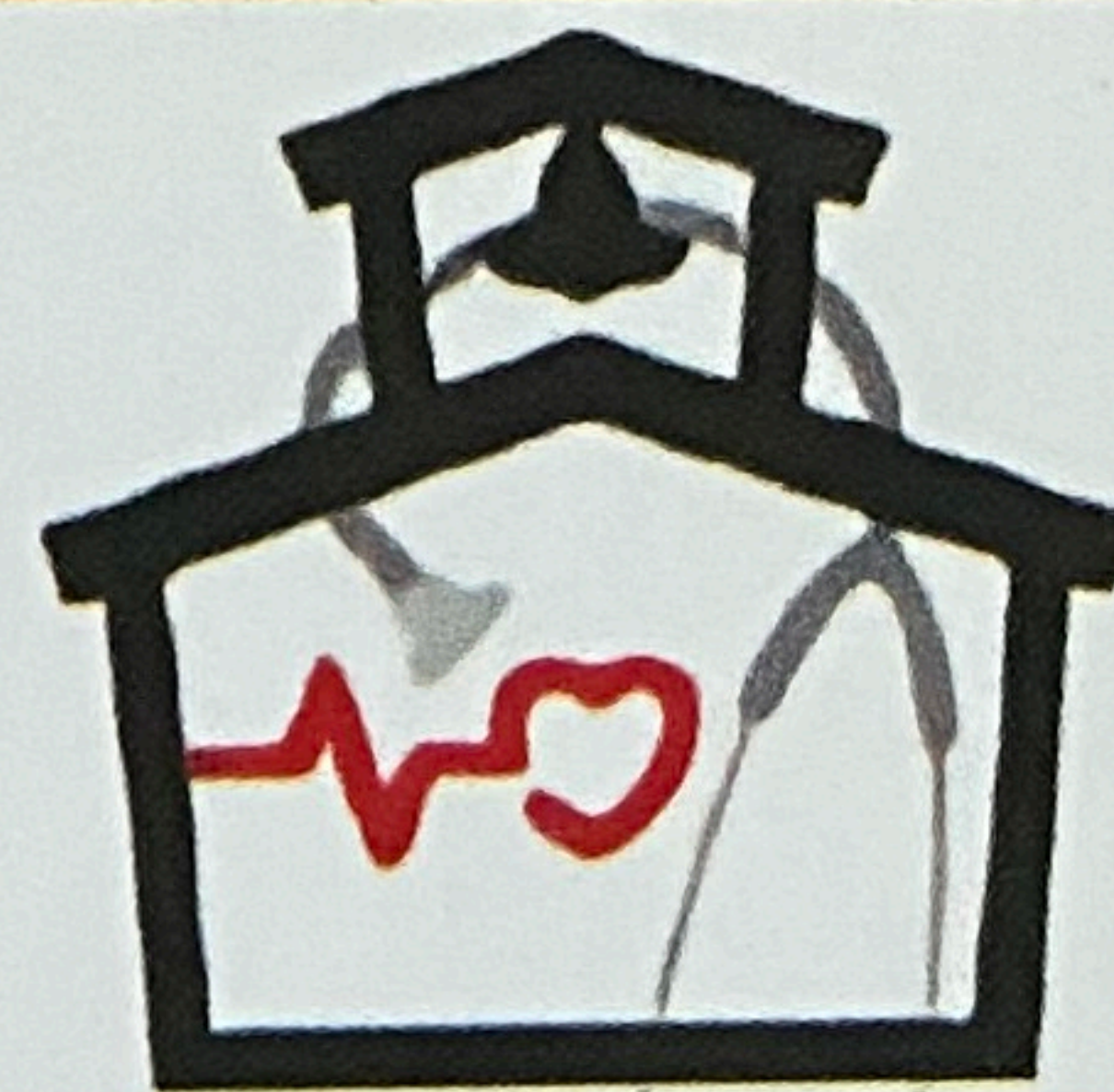
