A full-page print ad in the October 20, 2021 Mercer Islander Reporter made claims about alleged illegal activities by the union representing the Mercer Island Firefighters. At the bottom of the ad, it says, "Paid for by Seth Landau." The October 20, 2021 issue of the Mercer Island Reporter was available on newsstands on Tuesday, October 19, 2021 so a C-6 should have been filed on October 20, 2021.

Mr. Landau is aware of reporting requirements because when he purchased ads in the Mercer Island Reporter in 2019, he filed C-6 reports. Moreover, on or about October 21, 2021 Mr. Landau posted this on the social media site Next Door:

Seth Landau

• North Mercer Island
I did everything legally it's called C6 report and my name is on it just like on
the ad. I'm proud to do things legally and for our Island. This allows individuals
to do as I did. Totally legal. Whats your point? 4 days ago

As of 10 am on Monday October 25, 2021 there is no record on the PDC's website of Mr. Landau filing a C-6 for this independent expenditure. When the PDC was contacted shortly after 10 am, the staff person could not find any record of a C-6 filed by Mr. Landau and they suggested filing a complaint with the PDC.

This is a clear, MAJOR VIOLATION of campaign disclosure laws.

I am sure each candidate verified each contributor to their campaign, it has become such an issue in

A candidate that doesn't check their two dozen or so contributors, aspecially the few who give \$1,000 or

This "non-profit corporation" has nothing to do with the Fireman's Union. The union is not called "Mercer Island" anything. None of the contributions from "Mercer Island Professional Firefighters" are legitimized by the union.

This is where, in my opinion, the fraud is blatant.

We see the candidates state "Mercer Island Firefighters Endorsed" on their signs, mailers and other campaign material. Akyuz even headlined her newspaper ad with it.

The individual fire fighters of Mercer Island don't all support Akyuz, Weinberg and Becker.

Mercer Island Professional Firefighters, an unethical non-profit, is deceptive to the public.

The Aykuz, Weinberg and Becker campaigns received cash from this illegal non-profit corporation operating out of the Mercer Island Fire Station—with the station listed as its address.

This is the fire station of all Mercer Islanders; our government building; and many of us don't support the THAT IS ILLEGAL. candidates this non-profit gave secret money to

The PDC is currently investigating this matter and last week it was brought to the attention of the City Manager, the City Attorney and our Police Chief.
