Complaint Description
Glen Morgan 29 Dec 2021 To whom it may concern, It has recently come to my attention that 2021 candidate Parminder Singh Bhatti in his recent campaign for Hospital Commissioner has violated numerous Washington State campaign finance disclosure laws per RCW 42.17A .The violations are as follows: 1) Acceptance of illegal overlimit anonymous contributions (Violation of RCW 42.17A.220(4)) Based on the information reported by this campaign to the PDC, it appears that this campaign has accepted \$2,850.00 in anonymous contributions (See PDC C4 report #110065498 and PDC C4 Report #110066590 attached for reference) This campaign has only reported raising enough money to accept up to \$300 in anonymous contributions as the statute so clearly details in RCW 42.17A.220(4) , so at least \$2,550 must be forfeit to the State Treasurer of this secretive anonymous contribution. I only discovered this illegal secretive anonymous contribution because I noticed that Winpower Strategies was the paid consultant on this campaign and should have notified this client of this illegal series of secretive contributions, but clearly failed to do so. It has been my observation that candidates associated with the vendor Winpower strategies frequently violate Washington State campaign finance laws, and whether that is due to the quality of the consulting or other factors, I am not yet sure. Regardless, this is a fairly obvious violation, easily avoided by this campaign had they received proper campaign consulting/treasurer support. Instead, they broke the law and must forfeit these secretive anonymous funds to the State, to be squandered as most tax dollars are, as required by statute.
