To whom it may concern,

It has come to my attention, unfortunately, once again that the Washington Conservation Voters Action Fund PAC has committed repetitive and serious violations of Washington State's campaign finance laws (**RCW 42.17A**) during the 2021 election season. The details are as follows:

1) Failure to provide legally required details on Independent Expenditure Forms (Violation of RCW 42.17A.260(3)(C), WAC 390-16-037)

This well-funded PAC, which has the resources to hire professional compliance, legal, and treasurer support and which is very familiar with Washington State's campaign finance laws for decades of political activity still chose to knowingly break the law. This is all the more shocking considering the fact this professional, corporately funded PAC received a formal Written Warning issued by the PDC for previous violations of Washington's Campaign Finance Laws (See attached warning letter – **PDC Enforcement Case #42958**), and has also been fined \$300 by the PDC for previous similar violations based on complaints I have filed against them (See attached complaints and final settlement documents on **PDC Enforcement Case #59657 and Case #59539**)

This PAC has failed to provide legally required details about these independent expenditures which the law very clearly requires on these reports (See **WAC 390-16-037** for specific examples). This is a well-known statute and rule for this corporately funded and very experienced PAC and the political-veterans and professionals hired to manage this PAC know very well. They chose to ignore the law regardless.

Not only did this mega PAC fail to provide legally detailed information on their C6 reports as detailed above (and many examples are attached), they also failed to do so in the relevant expenditure reports (C4s). I have helpfully attached the relevant C4 reports for easy PDC staff reference, but as explained before, this PAC has refused to provide adequate details on many of these expenditures – how many texts did they send out? The ad buys are also lacking in details as noted on the attached C6 and C4 reports. **WAC 390-16-037** is very clear. The professional crew running this PAC knows the law. They just chose to ignore it, as they have often done in the past. It should be noted that in most cases, this information has been concealed from the public during the critical 21 days of this election.

These violations are particularly concerning in light of the fact that the PDC has already issued a Formal Warning to this mega PAC, and they were fined \$300 after that for additional violations, and despite that, they chose to beak the law just a few months later. It isn't clear if that Formal Warning and the PDC fine was viewed as a Green Light to break the law, knowing there would be no consequences, or if this PAC just felt that they have enough money, the risk of a fine was so low it didn't even matter. Perhaps they just enjoy mocking the PDC rules.

Either way, there isn't much to investigate here. They just need to start complying with the law, for a change and use some of their Mega corporate cash haul to comply with the law.

To whom it may concern,

It has come to my attention that Washington Conservation Voters Action Fund PAC has committed egregious, repetitive and serious violations of Washington State's campaign finance laws (**RCW 42.17A**).

1) Failing to file timely (24hours) Independent Expenditure Reports within 21 days of an election (RCW 42.17A.260(1)(b)(i))

This well-funded PAC, which has the resources to hire professional compliance, legal, and treasurer support and which is very familiar with Washington State's campaign finance laws for decades of political activity still chose to knowingly break the law. This is all the more shocking considering the fact this professional, corporately funded PAC has recently (earlier this year) received a formal Written Warning issued by the PDC for previous violations of Washington's Campaign Finance Laws (See attached warning letter – **PDC Enforcement Case #42958**).

Despite this warning, despite their resources, and despite their experience, they chose to break the law again.

Specifically, this PAC filed two different Independent Expenditure Reports during the 2019 election for a local political campaign in Washington State. In total, these two C6s detail \$40,000 of political advertising, which is a substantial sum in a local election, and they spent this money within the crucial 21 days of an election. It appears these ads were run locally in Whatcom County on October 18, 2019, and as you can see from the attached C6s these were not reported until October 23, 2019 - W

AY past the statutory deadline of 24hrs after publication.

2) Failure to provide legally required details on Independent Expenditure Forms (Violation of RCW 42.17A.260(3)(C), WAC 390-16-037)

This PAC has failed to provide legally required details about these independent expenditures which the law very clearly requires on these reports (See WAC 390-16-037 for specific examples). This is a well-known statute and rule for this corporately funded and very experienced PAC and the political-veterans and professionals hired to manage this PAC know very well. They chose to ignore the law regardless.

3) Failure to provide legally required details on PAC expenditure reports, nor do these reports match the information provided to the PDC in the C6 reports (Violation of RCW 42.17A.235, .240 and WAC 390-16-037)

Not only did this mega PAC fail to provide legally detailed information on their C6 reports as detailed above, they also failed to do so in the relevant expenditure reports (C4). I have attached this report for easy PDC staff reference, but as explained before, this PAC has refused to provide adequate details on this expenditure – who was it for? They also failed to provide the details about what it was (television ads, how many, when did they run? ETc). WAC 390-16-037 is very clear. The professional crew running this PAC knows the law. They just chose to ignore it.

Additionally, it should be noted that there might be a serious discrepancy in the funds reported on this C4 versus the C6s. \$20,000 appears to be missing. The two C6 reports indicate \$40,000 spent, but the C4 only reports \$20,000. For a PAC this size, they may not notice a missing \$20,000, but this is a substantial sum to find and resolve. This information has been concealed from the public during the critical 21 days of this election.

These violations are particularly concerning in light of the fact that the PDC has already issued a Formal Warning to this mega PAC, and despite that, they chose to beak the law just a few months after receiving the Warning. It isn't clear if that Formal Warning was viewed as a Green Light to break the law, knowing there would be no consequences, or if this PAC just felt that they have enough money, the risk of a fine was so low it didn't even matter.

Either way, this merits an investigation by the PDC to get to the bottom of this one.

Dear Bret Uhrich:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on November 6, 2018. Your complaint alleged that WA Conservation Voters Action Fund may have violated RCW 42.17A.320 for failure to accurately and completely disclose sponsor identification on text message based political advertising.

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; the response provided by WA Conservation Voters Action Fund; and PDC guidance concerning sponsor identification for text messages issued October 13, 2018, to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- On November 6, 2018, the WA Conservation Voters Action Fund admits to sending a
 text message to the number associated with Yvonne Uhrich, soliciting votes in support of
 candidates Rollins and Wolfe for Snohomish County Public Utility District
 Commissioners.
- In accordance with WAC 390-18-030(3)(b), and the "one-click" exemption for small online advertising, WA Conservation Voters Action Fund provided a link that recipients with Internet capable phones could click and be taken to a page containing the required sponsor identification disclosures.
- WA Conservation Voters Action Fund cites to the PDC guidance, issued October 13, 2018, concerning text message sponsor identification, but omits the guidance concerning alternative methods for non-Internet capable phones.
- WA Conservation Voters Action Fund did not provide an alternative to receive sponsor identification information for devices not capable of following the link, as provided in the PDC's guidance around sponsor identification in text messaging.

The guidance that WA Conservation Voters Action Fund cited in their response to the allegations states, "[s]ince some phones receiving the text will not be able to follow a link, we suggest campaigns include, in addition to a web address, mechanisms that allow the recipients to request sponsor ID information. Sponsors should make that process as easy as possible, perhaps by allowing the recipient to reply with a single character that then prompts another text message

with the sponsor ID information. The message would look something like this: 'Go to www.xyzcommittee.com or text * for sponsor information."

Based on these findings staff has determined that, in this instance, failure to provide an adequate avenue for voters to receive sponsor identification without connection to the Internet does not amount to an actual violation warranting further investigation.

Pursuant to WAC 390-37-060(1)(b), WA Conservation Voters Action Fund will receive a formal written warning concerning failure to provide an adequate avenue for voters to receive sponsor identification without connection to the Internet. The formal written warning will include staff's expectation that WA Conservation Voters Action Fund provides a mechanism in future political advertising for non-Internet capable devices to access the required sponsor identification disclosures quickly and easily. The Commission will consider the formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on November 6, 2018. Your complaint alleged that WA Conservation Voters Action Fund may have violated RCW 42.17A.320 for failure to accurately and completely disclose sponsor identification on text message based political advertising.

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; the response provided by WA Conservation Voters Action Fund; and PDC guidance concerning sponsor identification for text messages issued October 13, 2018, to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- On November 6, 2018, the WA Conservation Voters Action Fund admits to sending a
 text message to the number associated with Yvonne Uhrich, soliciting votes in support of
 candidates Rollins and Wolfe for Snohomish County Public Utility District
 Commissioners.
- In accordance with WAC 390-18-030(3)(b), and the "one-click" exemption for small online advertising, WA Conservation Voters Action Fund provided a link that recipients with Internet capable phones could click and be taken to a page containing the required sponsor identification disclosures.
- WA Conservation Voters Action Fund cites to the PDC guidance, issued October 13, 2018, concerning text message sponsor identification, but omits the guidance concerning alternative methods for non-Internet capable phones.
- WA Conservation Voters Action Fund did not provide an alternative to receive sponsor identification information for devices not capable of following the link, as provided in the PDC's guidance around sponsor identification in text messaging.

The guidance that WA Conservation Voters Action Fund cited in their response to the allegations states, "[s]ince some phones receiving the text will not be able to follow a link, we suggest campaigns include, in addition to a web address, mechanisms that allow the recipients to request sponsor ID information. Sponsors should make that process as easy as possible, perhaps by allowing the recipient to reply with a single character that then prompts another text message

with the sponsor ID information. The message would look something like this: 'Go to www.xyzcommittee.com or text * for sponsor information."

Based on these findings staff has determined that, in this instance, failure to provide an adequate avenue for voters to receive sponsor identification without connection to the Internet does not amount to an actual violation warranting further investigation.

Pursuant to WAC 390-37-060(1)(b), WA Conservation Voters Action Fund will receive a formal written warning concerning failure to provide an adequate avenue for voters to receive sponsor identification without connection to the Internet. The formal written warning will include staff's expectation that WA Conservation Voters Action Fund provides a mechanism in future political advertising for non-Internet capable devices to access the required sponsor identification disclosures quickly and easily. The Commission will consider the formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).

The Public Disclosure Commission (PDC) has completed its review of the complaints you filed on October 26, 2019 and October 30, 2019. The complaints alleged that the Washington Conservation Voters Action Fund, a continuing political committee, may have violated RCW 42.17A.235, .240 and WAC 390-16-037 by failing to completely and accurately disclose expenditure details on the Summary Full Campaign Contribution and Expenditure reports (C-4 reports); and RCW 42.17A.260 and .305 by failing to timely and accurately report independent expenditures and electioneering communications on Independent Spending and Electioneering Communications reports (C-6 reports) during the 2019 election year.

PDC staff reviewed the allegations and evidence you submitted; the applicable statutes, rules, and reporting requirements; the responses provided by the Washington Conservation Voters Action Fund (Committee); the applicable PDC reports filed by the Committee; and queried the Respondent's data in the PDC contribution and expenditure database to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- The Committee timely filed the C-4 reports due 21-days and 7-days prior to the General Election, disclosing expenditures which lacked the level of detail required by RCW 42.17A.240 and WAC 390-16-037, including a description of purpose sufficient to understand the nature of the expenditure and the number of items printed for political advertising.
- On October 15, 2019, the Committee timely filed the 21-Day Pre-General C-4 report, disclosing an October 7, 2019, expenditure of \$54,456 to Hopkins & Sachs, Inc. for "Consulting," which failed to itemize the \$54,456 expenditure, and an October 9, 2019 expenditure totaling \$20,000 made to SWAY for "digital advertising."
- On October 29, 2019, the Committee timely filed the 7-Day Pre-General C-4 report covering the period beginning October 15 through October 28, 2019, disclosing \$2,625 in contributions received and \$99,065 in expenditures made. The 7-Day Pre-General C-4 report disclosed three expenditures made to Hopkins &

Sachs, Inc., totaling \$26,747 for "Direct Mail," which failed to provide the number of items printed for political advertising, or who each expenditure supported or opposed, in accordance with RCW 42.17A.240 and WAC 390-16-037.

- On November 14, 2019, the Committee filed an amended 7-Day Pre-General Election C-4 report disclosing expenditures made to Hopkins & Sachs, Inc., totaling \$26,747 for "Direct Mail," which included two expenditures totaling \$18,027 for two direct mail pieces that supported candidates Satpal Sidhu, a candidate for County Council Member in Whatcom County, Natalie McClendon, a candidate County Council Member in Whatcom County and Carol Frazey, a candidate for County Commissioner for Whatcom County, in the 2019 election year. The other expenditure was for a direct mail piece totaling \$8,720, half of which supported the above-mentioned candidates and the other half opposed candidate Ben Elenbaas, a candidate for County Council Member for Whatcom County in the 2019 election year. The details of the expenditures, including the candidates supported or opposed, were disclosed 16 days late and nine days after the November 5, 2019 general election was held.
- On the same day, November 14, 2019, the Committee also amended the 21-Day Pre-General C-4 report disclosing that: (1) The \$54,456 expenditure to Hopkins & Sachs, Inc., was for direct mail (\$15,156) and for digital printing, advertising and production (\$39,300), all in support of Kristin Ang, a candidate for Port Commission for the Port of Tacoma; and (2) The \$20,000 expenditure made to "SWAY" for digital advertising was in support of Natalie McClendon, a candidate for the County Council Member for Whatcom County in the 2019 election year. The details of the expenditures, including the candidates supported and/or opposed, were disclosed 30 days late and nine days after the 2019 general election was held.
- On December 11, 2019, the Committee filed a C-6 report disclosing a \$15,156 expenditure to Hopkins & Sachs, Inc., for "26,236 pieces of Direct Mail in support of Kristin Ang," but stated that an additional \$39,000 in expenditures "covered a broad variety of mail, videos, website and other digital communications. All the communications were paid for by the Committee, but only a small fraction mentioned candidates the rest simply encouraged Washingtonians to vote. The only communication that advocated for candidates was a website, which accounted for \$6,000 of the \$39,300 expenditure. The pro rata attributable costs of the website did not reach the statutory threshold, so we did not include those costs on the Form C-6."
- On January 6, 2020, the Committee provided PDC staff with an itemization of the \$39,000 expenditure with sub-vendors utilized by the Committee, and amounts of the website attributable to each candidate, but expressed technical difficulties with space limitations to properly report this on C-4 reports.
- On January 31, 2020, the Committee amended its C-4 report to itemize each expenditure with the amount attributable to each candidate supported, and each sub-vendor utilized by the Committee, as required by RCW 42.17A.240, WAC 390-16-037 and WAC 390-26-205. The Committee also addressed the C-4 and C-6 reports discrepancy regarding the \$20,000 paid to SWAY in its response. The Committee indicated that it erroneously filed two, identical C-6 reports disclosing a single \$20,000 expenditure made to SWAY for "digital video" on October 16, 2019. Reporting such information twice inadvertently gave the public the false impression that the Committee spent a total of \$40,000. Shortly after the duplicate C-6 report (report# 9648) was filed, the Committee realized its mistake and contacted the PDC on October 23, 2019. The PDC has since resolved the issue of the duplicate C-6 so only a single \$20,000 expenditure now appears online (amended report #9942).

Based on the above review, staff has determined that non-compliance appears to be the result of a good-faith omission or errors by the Committee. According to the Committee, "non-compliance was unintentional, and the result of the delays caused by the unavailability of the primary person responsible for its campaign finance reporting, who was caring that week for a sick family member." The Committee also indicated that its attempts

to amend C-4 and C-6 reports to include additional expenditure details were frustrated by the 28-character field length limit in the description field of the PDC's online reporting system.

The Committee also made a good faith effort to cure the deficiencies listed in the complaint. After being notified of the complaints on October 26, 2019, and October 30, 2019, the Committee carefully reviewed its PDC reports and subsequently filed three additional C-6 reports (reports #9850, 9906 and 9931) amended ten C-6 reports to disclose previously unreported expenditures, clarified expenditures made and candidates supported, and modified expenditure descriptions to mirror the statutory requirements. The Committee did the same with its C-4 reports that lacked adequate descriptions and/or number of items purchased.

On April 7, 2020, the PDC received a fully executed electronic Statement of Understanding (SOU) signed by Shannon Murphy on behalf of the Committee, along with a \$300 civil penalty payment (received on April 16, 2020). By signing the SOU, the Committee acknowledged violations of RCW 42.17A.235 and .240, by failing to timely and accurately file C-4 reports.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).

To whom it may concern,

It continues to come to my attention (and the attention of anyone who bothers to look at their reporting) that Washington Conservation Voters Action Fund PAC continues to commit egregious, repetitive and serious violations of Washington State's campaign finance laws (RCW 42.17A).

1) Failure to provide legally required details on PAC expenditure reports(Violation of RCW 42.17A.235, .240 and WAC 390-16-037)

This well-funded PAC, which has the resources to hire professional compliance, legal, and treasurer support and which is very familiar with Washington State's campaign finance laws for decades of political activity still chose to knowingly break the law. This is all the more shocking considering the fact this professional, corporately funded PAC has recently (earlier this year) received a formal Written Warning issued by the PDC for previous violations of Washington's Campaign Finance Laws (See attached warning letter – **PDC Enforcement Case #42958**).

Not only did this mega PAC fail to provide legally detailed information on their C6 and C4 reports as detailed in my recent complaint filed with the PDC on October 26th, they continue to fail to follow the law in their more recent expenditure reports (C4). I have attached this report (**PDC Tracking** # 100942097) for easy PDC staff reference, but as explained before, this PAC has refused to provide adequate details on most expenditures – who was it for? How many pieces were mailed? WAC 390-16-037 is very clear. The professional crew running this PAC knows the law. They just chose to ignore it.

These violations are particularly concerning in light of the fact that the PDC has already issued a Formal Warning to this mega PAC, and despite that, they chose to break the law just a few months after receiving the Warning. It isn't clear if that Formal Warning was viewed as a Green Light to break the law, knowing there would be no consequences, or if this PAC just felt that they have enough money, the risk of a fine was so low it didn't even matter.

Either way, this merits an investigation by the PDC to get to the bottom of this one.

Dear Bret Uhrich:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on November 6, 2018. Your complaint alleged that WA Conservation Voters Action Fund may have violated RCW 42.17A.320 for failure to accurately and completely disclose sponsor identification on text message based political advertising.

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; the response provided by WA Conservation Voters Action Fund; and PDC guidance concerning sponsor identification for text messages issued October 13, 2018, to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- On November 6, 2018, the WA Conservation Voters Action Fund admits to sending a
 text message to the number associated with Yvonne Uhrich, soliciting votes in support of
 candidates Rollins and Wolfe for Snohomish County Public Utility District
 Commissioners.
- In accordance with WAC 390-18-030(3)(b), and the "one-click" exemption for small online advertising, WA Conservation Voters Action Fund provided a link that recipients with Internet capable phones could click and be taken to a page containing the required sponsor identification disclosures.
- WA Conservation Voters Action Fund cites to the PDC guidance, issued October 13, 2018, concerning text message sponsor identification, but omits the guidance concerning alternative methods for non-Internet capable phones.
- WA Conservation Voters Action Fund did not provide an alternative to receive sponsor identification information for devices not capable of following the link, as provided in the PDC's guidance around sponsor identification in text messaging.

The guidance that WA Conservation Voters Action Fund cited in their response to the allegations states, "[s]ince some phones receiving the text will not be able to follow a link, we suggest campaigns include, in addition to a web address, mechanisms that allow the recipients to request sponsor ID information. Sponsors should make that process as easy as possible, perhaps by allowing the recipient to reply with a single character that then prompts another text message

with the sponsor ID information. The message would look something like this: 'Go to www.xyzcommittee.com or text * for sponsor information."

Based on these findings staff has determined that, in this instance, failure to provide an adequate avenue for voters to receive sponsor identification without connection to the Internet does not amount to an actual violation warranting further investigation.

Pursuant to WAC 390-37-060(1)(b), WA Conservation Voters Action Fund will receive a formal written warning concerning failure to provide an adequate avenue for voters to receive sponsor identification without connection to the Internet. The formal written warning will include staff's expectation that WA Conservation Voters Action Fund provides a mechanism in future political advertising for non-Internet capable devices to access the required sponsor identification disclosures quickly and easily. The Commission will consider the formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
