Complaint Description

Glen Morgan reported via the portal (*Thu*, 30 Dec 2021 at 6:01 PM)

To whom it may concern,

It has recently come to my attention that the 45th Legislative District Democrats (Exempt) appear to have violated Washington State's campaign finance laws. The details are as follows:

1) Failure to properly identify as a sponsored committee (Violation of RCW 42.17A.005(47)(b)(i), WAC 390-16-011A)

This Party political committee received more than 80% of its funding from one donation from one source. Specifically, the Eastside Democratic Dinner Committee PAC (See the PDC filings from this committee – they only reported nine cents of "miscellaneous" income in addition to this \$7500 contribution. So, to be fair, during the 2021 calendar year, at least starting in September, they should have corrected their C1PC and renamed themselves the "45th Legislative District Democrats (Exempt) sponsored by the Eastside Democratic Dinner Committee PAC," but they did not follow the law.

The law is very clear, as **WAC 390-16-011A** clearly states:

"A sponsored political committee must amend its C-1pc sixty days before an election in which it participates if the committee's name on its most recently filed C-1pc does not include at least one current sponsor."

This political committee failed to comply with the law and correct it's C1PC documents to properly reflect that it was a wholly sponsored PAC with nearly 100% of its funding coming from another PAC. This was a flagrant effort to conceal the truth when using those same funding to provide extensive voter communication. This failure to properly correct its name means that every single mailer this organization distributed had inaccurate sponsorship information indicated in the Paid for disclaimer as well.

According to the C4s filed by this PAC, it appears they mailed or distributed about 26,000 brochures during the recent 2021 election.

Flagrant and significant violations of the Washington State Campaign finance laws like this should result in at least a formal warning in order to ensure that violations like this do not become habitual or repeated in the future.
