To whom it may concern,

It has come to my attention that failed Pend Orielle County Commissioner candidate Phyllis Kardos appears to have violated Washington State's campaign finance laws (**RCW 42.17A**) during her 2020 campaign. The details are as follows.

1) Failure to report or make an active effort to conceal government grant received for her cost-sharing on her property in 2019 on the annual financial affairs statement as filed with the public disclosure commission (Violation of RCW 42.17A.710(f), WAC 390-24-201(3)(b))

In reviewing the 2020 Financial Affairs Statement filed by failed Pend Orielle County Commissioner candidate Phyllis Kardos, it appears she violated the law by failing to report a \$3,948.00 Cost Sharing Grant provided to her property through her spouse by the Washington State Department of Natural Resources in 2019. I found this information by reviewing a list of DNR cost-sharing payments made to property owners in Pend Orielle County from 2015-2020. I have highlighted the payment in this DNR spreadsheet for your reference.

As you are aware, the F1 filed by failed candidate Phyllis Kardos in 2020 for the 2020 election should have included this information, but she chose to conceal and exclude it from the financial affairs statement instead.

Please note, it is possible and even likely that I have missed other unreported payments which should have been reported by this candidate to the PDC, but I wanted to provide this information to you now in the hopes that this candidate can come clean and be completely honest about all the information she has concealed from the public.
