Subject: Initial Order Reconsideration Hearing Notice, PDC Case Number 109561

Dear Mike Nykreim,

The Public Disclosure Commission (PDC) received your request for an appeal of the Initial Order issued in the case cited above. However, because your request was not received within 21 days of the August 11, 2022 Order, it is considered a request for reconsideration under WAC 390-37-150.

The Initial Order was issued pursuant to a brief adjudicative proceeding held on July 21, 2022, in which you were found in violation of RCW 42.17A.205 and assessed a penalty of \$250 with \$125 suspended if paid within 30 days of the date of the Initial Order.

RCW 42.17A.205 requires candidates to file a C-1 report within two weeks of declaring their candidacy, which was to have been filed no later than June 3, 2022.

Based on your request, an Initial Order Reconsideration Hearing has been scheduled in your case, as provided below. The Hearing will be held before the full Commission, in accordance with RCW 42.17A.110 and .755, and WAC 390-37-144. You will have an opportunity to explain your view of the matter if you choose to attend the Hearing.
