Subject: Complaint regarding Andrew Stokesbary, PDC Case 30704

Dear Washington State Democrats:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on January 31, 2018. Your complaint alleged that Andrew Stokesbary may have violated RCW 42.17A.220 or RCW 42.17A.235 for reporting deposit of contributions before deposits have been made.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- RCW 42.17A.220 requires deposits to be made within 5 business days of receipt of contributions, which RCW 42.17A.235 requires be filed on the tenth day of the month, or each Monday in the five months before the general election.
- Andrew Stokesbary's campaign made deposits within 5 business days of receipt of contributions in accordance with RCW 42.17A.220.
- Andrew Stokesbary's campaign filed C-3 reports of Cash Receipts and Monetary Contributions prior to making deposits on the required dates, in substantial compliance with RCW 42.17A.235.

Based on these initial findings, staff has determined that in this instance, no evidence supports a finding of a material violation warranting further investigation.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
