It was reported via the attached C3, as received and deposited to the campaign account.</p> <p>However, the C4 report filed for April 1-30 reports no contributions at all. In a 7 day period-- - \$1000 goes missing? Disappears? Gets spent? No, there's no reported expenditures either.</p> <p>So - \$1000 arrives April 10, it looks like. Is deposited to the campaign account on April 23rd, a couple of weeks later.
