Subject: Kurtis Engle Enforcement Hearing Memorandum: PDC Case #111938

#### **Allegations:**

PDC staff alleges that Kurtis Engle, a candidate for Secretary of State in the 2022 election, violated of RCW 42.17A.235 & .240 for failure to timely and accurately file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contributions and expenditures undertaken by the Campaign as required by campaigns registered under the "Full Reporting" option.

#### **Background:**

- Kurtis Engle was a candidate for Secretary of State in the August 2, 2022 Primary Election and received 0.37% of the vote. Mr. Engle's name will not appear on the November 8, 2022 General Election.
- Mr. Engle declared his candidacy for Secretary of State on May 20, 2022.
- On June 16, 2022, Kurtis Engle filed the C-1 report, selecting the "Full Reporting" option and listing himself as Treasurer and the only officer. [Exhibit A]
- On August 28, 2022, PDC staff received a complaint filed by Conner Edwards alleging that Kurtis Engle had violated of RCW 42.17A.235 & .240 for failure to timely and accurately file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contributions and expenditures undertaken by the Campaign as required by campaigns registered under the "Full Reporting" option. Kurtis Engle October 20, 2022, Enforcement Hearing Memo PDC Case No. 111938 Page - 2 –

- PDC staff sent notice of the complaint to Mr. Engle on September 1, 2022 and requested a response by September 15, 2022. [Exhibit C]
- When no response was received and no reporting was done, staff sent a second notice of the complaint to Mr. Engle on September 16, 2022 and requested a response by September 26, 2022. [Exhibit C]
- On September 29, 2022, PDC staff served Kurtis Engle, by U.S. mail and electronic mail, with a hearing notice for a Brief Adjudicative Proceeding to be held on October 20, 2022, concerning alleged violations RCW 42.17A.235 & .240 for failure to timely and accurately file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contributions and expenditures undertaken by the Campaign as required by campaigns registered under the "Full Reporting" option. [Exhibit D]
- On October 3, 2022, PDC staff spoke to Mr. Engle by telephone. Mr. Engle requested to participate in the October 20, 2022 Brief Adjudicative Proceeding.
- On October 8, 2022, Kurtis Engle submitted a written response for PDC Case #111938. [Exhibit E]

#### Laws & Rules:

RCW 42.17A.235 and RCW 42.17A.240 require candidates to file timely, accurate reports of contributions and expenditures. Under the "Full Reporting" option, until five months before the general election, C-3 and C-4 reports are required monthly when contributions exceed \$200 since the last report; on the twenty-first day and the seventh day preceding the date of the primary and general election date; and on the tenth day of the first month after the primary and general election date.

Hello:

The committee "Kurtis Engle" (2022) appears to have failed to timely file C4s.

This candidate filed as "full-reporting" however has not filed a single C3 or C4 report. This candidate would have been required to file a May C4 report because of the filing fee for this office being greater than \$200, and of course would have been required to file both the 21-day and 7-day pre-election report because they were on the ballot in the primary. See attached.

#### **Letter to Respondent**

To Whom It May Concern:

I apologize for filing this complaint against your campaign/committee. It is not my intention to cause you any inconvenience. I am filing a batch of complaints against campaigns/committees that have failed to timely file C4s in recent election cycles to demonstrate the PDC's unwillingness to meaningfully enforce the statutory requirement to timely file C4s described in RCW 42.17A.235.

This is a relevant issue because the PDC appears poised to propose dramatically increasing the number of C4s that filers would be required to file in the month leading up to the primary and general elections. If this proposal were to be adopted by the Legislature, it would dramatically increase the amount of work that campaign treasurers and committees would be required to perform. The agency has offered little in the way of evidence to suggest that this proposal would result in any meaningful benefit to the voting public.

Currently, the agency does not actively investigate campaigns/committees to determine whether they have timely filed C4 forms. The agency *does* do this as it relates to the timely filing of C1/F1 forms. When adjudicating complaints alleging late C4 reporting, the PDC has leaned heavily on the use of "warning letters". These letters are, in essence, dismissals, and are not a meaningful deterrent for those who would engage in late reporting.

Put simply, the agency's rhetoric ("C4s contain valuable information for voters; any additional burden to filers stemming from increased reporting is justified") does not match the agency's actions (dismissing complaints that demonstrate filers haven't filed C4 reports on time).

By highlighting the agency's failure to meaningfully enforce current reporting deadlines, my hope is that the agency will look to improve its own enforcement procedures before saddling filers with additional reporting obligations.

No campaign treasurer or campaign/committee is perfect. Trying to comply with the myriad of requirements and deadlines the PDC enforces can be extremely difficult, even for those who have been doing this for years. The agency could adopt any number of strategies to help filers "get it right" when it comes to deadlines and other requirements. Some of these strategies might include: a) automated electronic filing reminders to a filer when they have missed a deadline, b) mandatory attendance in a PDC training course before a person is allowed to serve as treasurer, and c) giving filers 48 hours to file 21- & 7-day pre-election reports as opposed to the 24 hours we currently get.

The Public Disclosure Commission (PDC) is investigating a complaint filed on August 28, 2022 by Conner Edwards. The complaint alleges that you, a candidate in the 2022 election for Secretary of State, may have violated RCW 42.17A.235 & .240 for failure to timely and accurately file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contributions and expenditures undertaken by the Campaign as required by campaigns registered under the "Full Reporting" option.

In accordance with RCW 42.17A.110 and RCW 42.17A.755, a Brief Adjudicative Proceeding (Brief Enforcement Hearing) has been scheduled to determine if you violated RCW 42.17A.235 & .240 by failing to timely and accurately file C-3 and C-4 reports. Under the Brief Enforcement Hearing rules, the Presiding Officer has the authority to assess a civil penalty in accordance with WAC 390-37-143, a penalty schedule adopted by the Commission (see enclosed copy).

"Occasion" means established violation. Only violations in the last five years will be considered for the purpose of determining second and third occasions.

- (2) In determining the appropriate penalty, the presiding officer may consider the nature of the violation and aggravating and mitigating factors, including:
  - (a) Whether the respondent is a first-time filer;
- (b) The respondent's compliance history for the last five years, including whether the noncompliance was isolated or limited in nature, indicative of systematic or ongoing problems, or part of a pattern of violations by the respondent, or in the case of a political committee or other entity, part of a pattern of violations by the respondent's officers, staff, principal decision makers, consultants, or sponsoring organization;
- (c) The respondent's unpaid penalties from a previous enforcement action;
- (d) The impact on the public, including whether the noncompliance deprived the public of timely or accurate information during a timesensitive period, or otherwise had a significant or material impact on the public;
- (e) The amount of financial activity by the respondent during the statement period or election cycle;
- (f) Whether the late or unreported activity was significant in amount or duration under the circumstances, including in proportion to the total amount of expenditures by the respondent in the campaign or statement period;
- (g) Corrective action or other remedial measures initiated by respondent prior to enforcement action, or promptly taken when noncompliance brought to respondent's attention;
- (h) Good faith efforts to comply, including consultation with PDC staff prior to initiation of enforcement action and cooperation with PDC staff during enforcement action, and a demonstrated wish to acknowledge and take responsibility for the violation;
- (i) Personal emergency or illness of the respondent or member of his or her immediate family;

- (j) Other emergencies such as fire, flood, or utility failure preventing filing;
- (k) Sophistication of respondent or the financing, staffing, or size of the respondent's campaign or organization; and
- (1) PDC staff, third-party vendor, or equipment error, including technical problems at the agency preventing or delaying electronic
- (3) The presiding officer has authority to suspend all or a portion of an assessed penalty under the conditions to be determined by that officer including, but not limited to, payment of the nonsuspended portion of the penalty within five business days of the date of the entry of the order in that case.
- (4) If, on the third occasion, a respondent has outstanding penalties or judgments, the matter will be directed to the full commission for consideration.
- (5) The presiding officer may direct a matter to the full commission if the officer believes one thousand dollars would be an insufficient penalty or the matter warrants consideration by the full commission. Cases will automatically be scheduled before the full commission for an enforcement action when the respondent:
  - (a) Was found in violation during a previous reporting period;
  - (b) The violation remains in effect following any appeals; and
- (c) The person has not filed the disclosure forms that were the subject of the prior violation at the time the current hearing notice is being sent.

I'm actually quite ill.

A few weeks before filing week I managed to get into the mail an essay I had been writing for a year. The subject matter kept kicking my \*ss and chasing me off. I was writing the folks who alter Navy records about changing mine. To do that I had to say why, and to do that I had to THINK, long, hard, and carefully, about things that happened long ago so awful I have refused to think about it for decades. Either those officers were able to hate that much and that easily, or they forgot they were punishing me, and so it just went on forever. Either would be more disturbing than the other. But what hit me in the eye was the shadow the incident cast over the rest of my life. The cost is incredible, and being able to see that clearly is new. I was always afraid to look, before. This triggered an attack of my severe, recurrent, depression. Add to this 4 surgeries and a root canal, this year, and another surgery in a month. A bit distracting.

I get paid \$51,000, this year, due to some of these matters. That is the source of all of my funds. I expect the essay to be worth about \$100,000 and about \$20,000 annually, so, important. I have never requested or accepted a political donation. I'm not a politician. I filed in this race because it was possible there would be an argument about trusting our voting system. As it turned out there was little of that, here. I was pleased to have the luxury of addressing personal matters instead (if I can put it that way). I am pleased by the way the election turned out and would vote for either of the remaining SOS candidates.

Regarding the PDC reporting and related hearings, there were three items I found non-functional. Two of these relate to disability, the last is just plain bad equipment.

First, the format of what amounts to Flash Cards deprives the victim of all landmarks and any sense of where he is going, how long the journey, and what is under his foot until he plants it. While some might not be bothered, others are. I think that someone thought of this as a cruel joke. If that is not so, then I would like to tell you that it is a cruel joke. In future adopt a format that allows the victim to see the entire problem on one page. Electric paper rolls on forever. You have no excuse.

In future,

please ask folks for their brokerage account numbers and do the busywork for us. You can do it in seconds, while it would take us a month. Or... ask in a way it can be answered in a minute.

Third, Microsoft Teams is a non-legal choice to conduct government business on because Microsoft insists I prove who I am to them. To the extent microsoft maintains a database of peoples particulars it is an offense not a service. And the extent of their maintenance is limited. I would have to do three impossible things to prove who I am. Sending me a link via email should adequately establish my identity to attend a government hearing.

In conclusion, I mention I paid the fine and consider the matter settled. If that isn't so, I would mention that is because I wasn't allowed to attend the hearing.
