Dean Hachamovitch intentionally omitted a corporation from his Financial Affairs Disclosure for calendar year 2021 for which he is the sole officer, and has so served since its formation in 2014. Dean Hachamovitch further intentionally lied in such Disclosure when he claimed he had no debt in excess of \$2,400 when he knew the City of Clyde Hill had issued him a invoice for unpaid legal fees and hearing examiner fees in October 2021 for nearly \$8,000 which amount remained due and unpaid when the Disclosure was filed. Dean Hachamovitch has still filed no reports or information regarding his donations or expenditures for his successful contested 2021 campaign for election.

## What impact does the alleged violation(s) have on the public?

Candidate Hachamovitch failed to file any data about his campaign donations or expenditures depriving the public of any means to assess the impact such donations and expenditures had on the campaign and to hold him to election transparency. But deliberately omitting a debt of nearly \$8,000 to the City for which he was running for election, and the status as sole officer of a Washington State registered corporation, candidate and now Councilmember Hachamovitch has deprived the public information regarding his debts and business affiliations he was mandated by law to disclose.

Dear Public Disclosure Commission:

This is a complaint to the PDC against **Dean Hachamovitch** for violations of state law and PDC requirements and rules. Dean Hachamovitch ran in a contested election for Position 5 of the Clyde Hill City Council in 2021 and won. He currently serves as Clyde Hill City Councilmember Position 5.

## I. <u>A DESCRIPTION OF THE ALLEGED VIOLATION(S) AND THE NAME OF THE PERSON OR ENTITY RESPONSIBLE ("RESPONDENT"):</u>

The person responsible for the violations (the respondent) is **Dean Hachamovitch**, current Clyde Hill City Councilmember, and a 2021 candidate for the position of Clyde Hill City Councilmember.

The description of the violations are as follows:

- (1) Dean Hachamovitch has knowingly and intentionally lied on his Financial Affairs Disclosure for calendar year 2021 by failing to disclose a debt of more than \$7,948.40 owed to the City of Clyde Hill, the very entity on which he serves as Councilmember and was running in 2021 for the position of Councilmember.
- (2) Dean Hachamovitch has further knowingly and intentionally lied on his Financial Affairs Disclosure by failing to disclose an LLC for which he is, and at all times since 2014 was, the sole officer.
- (3) Dean Hachamovitch has failed to file any report for his 2021 campaign.

Clyde Hill is run by an elected five-member City Council. Dean Hachamovitch ran in a contested election for Position 5 of the City Council in 2021, won, and was sworn in as a Councilmember. The PDC website shows he reported zero dollars in campaign donations or expenditures for that campaign. See **Exhibit F** hereto, a screen shot of the PDC website report available at <a href="https://www.pdc.wa.gov/political-disclosure-reporting-data/browse-search-">https://www.pdc.wa.gov/political-disclosure-reporting-data/browse-search-</a>

<u>data/candidates</u> (last visited 9/27/2022) and the only campaign data listed with the PDC, available at <a href="https://www.pdc.wa.gov/political-disclosure-reporting-data/browse-search-data/candidates/449740">https://www.pdc.wa.gov/political-disclosure-reporting-data/browse-search-data/candidates/449740</a> (last visited 9/27/2022).

The only report Dean Hachamovitch apparently has filed with the PDC is his Financial Affairs Disclosure for calendar year 2021, filed on April 13, 2022, attached hereto as **Exhibit A** and available at <a href="https://apollo.pdc.wa.gov/public/financial-affairs/statement/106345">https://apollo.pdc.wa.gov/public/financial-affairs/statement/106345</a> (last visited 9/27/2022).

## A. INTENTIONALLY AND KNOWINGLY LYING ON HIS FINANCIAL AFFAIRS DISCLOSURE FOR CALENDAR YEAR 2021:

Dean Hachamovitch filed a Financial Affairs Disclosure for calendar year 2021 on April 13, 2022. It is attached hereto as **Exhibit A** (available at <a href="https://apollo.pdc.wa.gov/public/financial-affairs/statement/106345">https://apollo.pdc.wa.gov/public/financial-affairs/statement/106345</a> (last visited 9/27/2022).

In the Disclosure, Councilmember Hachamovitch was required to disclose whether he had any debts in excess of \$2,400 and if so to whom, and to disclose the names of all businesses for which he or his spouse are a 10 percent or more owner <u>or</u> on which either serves as an "officer, director or general partner". In this Disclosure Councilmember Hachamovitch claims only two businesses meet these criteria: (1) The Hannah Arendt Center for Politics and Humanities at Bard College in New York, and (2) Bldg Five LLC. See **Ex. A at Pages A-4 to A-5.** No business affiliations are listed for his spouse Joan Ellen Morse Hachamovitch. <u>Id.</u> Councilmember Hachamovitch states in the disclosure "There is no debt in excess of \$2,400." See **Ex. A at Page A-4.** 

This Disclosure is made under penalty of perjury and is certified as complete and accurate both by the person filing it and the person on whose behalf it was filed. See, e.g., RCW 42.17A.145.

Councilmember Hachamovitch's Financial Affairs Disclosure for calendar year 2021 contains intentional and knowing omissions in two respects. First, Councilmember Hachamovitch lied when he claimed on April 13, 2022, that he had no debts in excess of \$2,400 in 2021. Second, Councilmember Hachamovitch deliberately omitted at least one Washington business for which he serves as the sole officer, and has since its formation in 2014.

## 1. Omission of Nearly \$8,000 Debt Owed to City of Clyde Hill at Time of Filing:

Dean Hachamovitch filed a land use appeal with the City of Clyde Hill which required the City of Clyde Hill to incur hearing examiner fees and legal fees. Pursuant to the City's then, and current, policy, when Mr. Hachamovitch as the appealing party then dropped his appeal, the City charged him for the hearing examiner's and legal fees incurred by the City as a result of his unsuccessful appeal. On October 22, 2021, the City of Clyde Hill issued Dean Hachamovitch an invoice for the \$7,948.40 it had incurred in hearing examiner's and legal fees on his appeal. A true and correct copy of this invoice, publicly disclosed by the City of Clyde Hill, is attached hereto as **Exhibit B**. On April 13, 2022, when Dean Hachamovitch filed his Financial Affairs Disclosure with the PDC for calendar year 2021 he had not yet paid any portion of this debt and still owed the full amount.

Despite this, Dean Hachamovitch falsely stated in his April 13, 2022 Disclosure "There is no debt in excess of \$2,400." See **Ex. A at Page A-4.** This statement was untrue. Whether or not he believed the amount was reasonable, it was nonetheless a debt he owed to the City to reimburse taxpayers for the expense the City incurred defending against his unsuccessful appeal. There is no legitimate credible excuse for his deliberate omission of this debt from his PDC Financial Affairs Disclosure on April 13, 2022.

## 2. Omission of Business for Which Councilmember Hachamovitch is and was its Sole Officer:

Councilmember Hachamovitch deliberately omitted at least one business for which he served as the sole officer in 2021 and has so served since its formation in 2014.

The 2022 Washington Secretary of State's current corporate listing for "Dean Hachamovitch LLC" is attached hereto as **Exhibit C**. The 2021 Annual Report filed with the Washington State Secretary of State by Dean Hachamovitch LLC is attached hereto as **Exhibits D**. The Annual Reports filed by this entity with the Washington State Secretary of State from 2015 to 2020 are attached here as **Exhibit E**. Each of these Exhibits shows that Dean Hachamovitch is and was the sole officer of Dean Hachamovitch LLC at the time of those filings.

Dean Hachamovitch was aware he was an officer, and the sole officer, of Dean Hachamovitch LLC, and yet he failed to disclose this affiliation on his Financial Affairs Disclosure for calendar year 2021 (**Exhibit A**). There is no legitimate credible excuse for his deliberate omission of this business from his PDC Financial Affairs Disclosure.

## B. <u>FAILURE TO FILE ANY REPORTS OR DATA FOR HIS 2021</u> CAMPAIGN:

Dean Hachamovitch ran in a contested election in 2021 for Position 5 of the Clyde Hill City Council. **Exhibit F** shows that candidate Hachamovitch to this day has not reported any information about the donations received or expenditures made during that campaign, and he is known to have had campaign-related expenditures including signage and other promotion. Candidate Hachamovitch should immediately be made to submit to the PDC reports showing all campaign-related data for his 2021 campaign.

### II. LAW(S) OR RULE(S) VIOLATED:

Dean Hachamovitch has violated RCW 42.17A. et seq. including 42.17A.235, .240, .700, .710 and WAC 390-16-037 among others. He violated RCW 42.17A.235, .240 and WAC 390-16-037 for failure to timely and accurately describe campaign contributions and expenditure reports for election year 2021 (C-3 and C-4 reports and other campaign reporting). He violated RCW 42.17A.700 and .710 for failure to file an accurate, truthful and complete Personal Financial Affairs Statement (F-1 report) as a candidate and an elected official as he intentionally hid a nearly \$8,000 debt and a corporation of which he is the sole officer.

# III. ALL AVAILABLE DOCUMENTS AND OTHER DOCUMENTARY EVIDENCE OR STATEMENTS DEMONSTRATING A REASON FOR BELIEVING THAT THE VIOLATION(S) OCCURRED:

**Exhibit B** is the invoice and supporting documents issued to Dean Hachamovitch by the City of Clyde Hill on October 22, 2021 for a debt he owed to the City of \$7,948.40. See **Ex. B** at **Page B-1**.

The Annual Reports filed with the Washington Secretary of State by Dean Hachamovitch LLC from 2015 to 2021, and the screen shot showing its current status, are attached hereto as **Exhibits C-E**. These show that Councilmember/former candidate Hachamovitch has been the sole officer of this corporation since its formation in 2014.

Dean Hachamovitch's Financial Affairs Disclosure for calendar year 2021 – the only one he ever filed with the PDC – is attached hereto as **Exhibit A.** It was filed on April 13, 2022. This shows Councilmember Hachamovitch failed to disclose Dean Hachamovitch LLC, for which he is the sole officer, on that disclosure. This also shows that Councilmember Hachamovitch falsely stated in that Disclosure "There is no debt in excess of \$2,400." **Ex. A at Page A-4.** On April 13, 2022 when Councilmember Hachamovitch filed this Disclosure, he knew he still owed the City of Clyde Hill nearly \$8,000, that had not yet been paid, despite being invoiced in October 2021. See **Ex. B at Page B-1.** 

**Exhibit F** are screen shots from the PDC's website showing Councilmember/former candidate Hachamovitch has not reported any donations or expenditures for his contested 2021 campaign even though the election is over and such filings are long past due.


