To whom it may concern,

It has come to my attention, once again, that failed state legislative candidate for the 37th Legislative District Andrew Melvin Ikechukwu Ashiofu appears to have violated Washington State's campaign finance laws (RCW 42.17A), during the recent 2022 campaign. I will detail these violations below:

1) Acceptance of illegal overlimit in-kind contributions to political campaign (Violation of RCW 42.17A.405, WAC 390-16-207, WAC 390-05-235(4))

I was surfing through the PDC website recently and I stumbled on some filings from this campaign which appear to reflect a total disregard for the campaign finance laws of Washington State. Specifically, in the case of failed state legislative candidate for the 37th Legislative District Andrew Melvin Ikechukwu Ashiofu, he repeatedly appears to have accepted substantial contributions – mostly in-kind – which far exceed the maximum limit allowed as defined under RCW 42.17A.405.

For example, he reported a cumulative in-kind contribution amount of \$17,331 of "in-kind" contributions from a "MrLang Solutions, LLC," which is approximately \$16,331 more than would be legally allowed for this campaign to received during a failed primary campaign. I will also point out that "MrLang Solutions, LLC" appears to match a defunct corporate registration with the Secretary of State for a company that was administratively dissolved in 2021, the year before this campaign was launched. I've attached the original corporate filing for this organization which listed a Governor named "Matthew R. Lang" on the corporate filing documents.

Another weird aspect of this illegal overlimit contribution to this campaign was that these contributions were defined or explained in PDC Report #110110130 as "Debt Forgiven" which is a weird way to describe these in-kind contributions if they are in fact "debt." If they were "debt", then this is a separate violation of unreported debt to this campaign.

Additionally, this wasn't the only example of an illegal overlimit contribution to this campaign. Two cash contributions of \$1,000 each were given to this campaign by a Agatha Ashiofu on 5/9/2022 (See PDC Report # 110086989). Although this was broken down into \$1k for General and \$1k for the Primary, the extra \$1k appears to have not been reimbursed yet.

I will note, for the record, that this was a first-time candidate for office, who used a shady consultant organization — WinPower strategies, who was paid \$5,892.89 for some "consulting" which apparently didn't include an elementary review of PDC compliance and after taking the cash, this consulting group left Mr. Ashiofu holding the bag and a total defeat in the recent 2022 elections. The money raised by this campaign appears to have been squandered on nothing much to help him get elected, and while I realize it isn't the PDC's responsibility to ensure campaigns spend their money rationally or even with a dose of common sense, it is my opinion that a variety of consultant organizations exist out there to extract their cash from candidates like this who have little chance of success when they file to run for office like this, and it doesn't help if they are allowed to blunder into obvious campaign finance violations like this one.

Consulting organizations like WinPower Strategies should be forced to bear at least some of the financial burden for squandering a new candidate's limited funding. Mr. Ashiofu deserves a complete rebate for the money he squandered on these guys.
