<p>Glen Morgan 26 Jan 2023 at 1:36 PM</p> <p>To whom it should concern,</p> <p>It has come to my attention that Snohomish County Sheriff candidate Susanna Karlina Johnson has failed to comply with Washington State's campaign finance laws (RCW 42.17A). The details are as follows:</p> <p>1) Failure to file Personal Financial disclosure information (F-1) in a timely manner (Violation of RCW 42.17A.700)</p> <p>This candidate launched her well funded campaign for Snohomish County Sheriff's office in October, 2022 (See attached). According to RCW 42.17A.700 (2) , this candidate would be required to file a Personal Financial Disclosure Report (F-1) within a few weeks of the launch of her campaign for calendar year 2021 (or previous 12months). I can find no F-1 filed for this candidate anywhere on the PDC website. It appears she is many months late and the public has a right to see this report.</p> <p>Additionally, a new report will be due in a few months from now for Calendar year 2022, and it would be worth directing PDC staff to pay additional attention this this campaign since it would appear compliance with Washington State Law is not a priority for them at this time.</p> <p>Let me know if you need any additional information.</p> <p>Best Regards,</p> <p>Glen Morgan</p>
What impact does the alleged violation(s) have on the public?
<p>The public has a right to see the personal financial statement of someone running for such an important office. This is important so that people can judge for themselves if there are any shady elements behind the candidate for office, including conflicts of interest, etc. The public also has a right to know if someone running for office in theory to enforce the law will actually follow the law themselves. In this case, it doesn't look like it.</p>

Both the treasurer and the candidate should be able to resolve this legal problem. It is a shame there was some type of effort to conceal this information from the public.
