It has recently come to my attention that the Support Ferndale Schools PAC has violated Washington State campaign finance disclosure laws per RCW 42.17A. The violations are as follows:

1) Acceptance of illegal overlimit anonymous contributions (Violation of RCW 42.17A.220(4))

Based on the information reported by this campaign to the PDC, it appears that this campaign has accepted \$430.00 in anonymous contributions (See PDC C3 report #110066379 attached for reference) This campaign has only reported raising enough money to accept up to \$300 in anonymous contributions as the statute so clearly details in RCW 42.17A.220(4), so at least \$130.00 must be forfeit to the State Treasurer of this secretive anonymous contribution.
