Re: PDC Complaint #124392 – Alleged violations of RCW 42.17A.555 concerning informational mailer on Regional Fire Authority involving Olympia & Tumwater Fire Departments

Dear Mr. Young:

I represent the cities of Olympia and Tumwater (collectively "the Cities") concerning the complaints filed by Robert Shirley and Arthur West alleging violations of RCW 42.17A.555 arising from an informational mailer sent by the Cities to their citizens concerning the proposed formation of a Regional Fire Authority (RFA). This letter responds to the requests for information sent to Olympia City Manager Jay Burney in your email sent on April 18, 2023 at 6:25 p.m.

As a preliminary matter, the ability to inform the citizens of public issues, especially proposals placed on the ballot for action by those citizens is an important matter of public concern. Indeed, the PDC's guidance acknowledges that the production of information "is not only the right, but the responsibility of local government to inform the general public of the operational and maintenance issues facing local agencies." PDC Interpretation 04-02, Guidelines for Local Government Agencies in Election Campaigns. This duty was emphasized by the PDC in its January 12, 2015 guidance on Election-Related Communications by Local Government Agencies.

The First Amendment to the Constitution recognizes the need to have an informed electorate and to permit a broad discourse with the public to carry out this important public duty. Nevertheless, two opponents of the RFA have complained, immediately before the conclusion of the voting period, in order to denigrate the Cities and their efforts to inform the voters. They do so by alleging that the Cities spoke unlawfully in the informational flyer sent to the citizens. This complaint appears calculated to use the provisions of RCW 42.17A.555 to chill the ability of the Cities to carry out their duties to inform the public about these ballot measures. The PDC should acknowledge this context and treat such complaints with a critical eye that is skeptical of the political motivations of the complainants.

As well, the PDC must be mindful of the legal requirements imposed by our Legislature concerning formation of regional fire authorities, which must be approved by both the legislative bodies of the jurisdictions involved and submitted to the voters for their consideration and approval. The Cities entered into an interlocal agreement in 2021 to establish a planning committee that would consider planning for a regional fire authority as provided in Chapter 52.26 RCW. Under RCW 52.26.060, a plan for the RFA must be provided by the planning committee to the governing bodies of each fire protection jurisdiction to certify the plan to be submitted to the ballot.

Thus, under RCW 52.26.060, cities who desire formation of a regional fire authority are placed in the position of being proponents of the ballot measure who are nevertheless constricted by the PDC's guidance on what it may permissibly express to the voters who are weighing this measure. This places the PDC in the role of weighing what is permissible speech by the Cities in informing the citizens as to the reasons why the Cities have placed the measure before them. Rather than limiting the Cities' ability to communicate with the public on matters of clear public concern, the PDC should approach its role with caution and circumspection given the clear First Amendment implications of its investigatory functions.

Additionally, the PDC has informed the Cities that it no longer has the resources to comment on proposed informational mailers to provide guidance as to compliance with RCW 42.17A.555, leaving local governments in the dark as to the application of the PDC's guidance and at risk of possible enforcement after the exercise of the speech contemplated as their duty. As such, any city is in the unenviable position of either risking after-the-fact consequences if the information provided to its citizens is deemed "promotional" or fails to include speech that opponents desire to include in the public discourse, including statements that the city would believe are incorrect or would be misleading.

With these concerns now stated, I turn to the questions posed by your April 18, 2023 email to Mr. Burney. These questions are as follows:

- When did the Olympia and Tumwater City Council's approve the resolution placing the Olympia-Tumwater Regional Fire Authority District measure on the ballot?
 - RESPONSE: The Cities both adopted resolutions to place the RFA measure on the ballot on Tuesday, December 6, 2022. The City of Olympia adopted Resolution M-2400. The City of Tumwater adopted Resolution R2022-014. These resolutions are attached.
- Please provide a summary of the timeline concerning the City of Olympia efforts
 concerning the possible creation of the Olympia-Tumwater Regional Fire Authority
 District (OTRFA) and be sure to include a summary of the work and ultimate approval of
 the Interlocal agreement approved by the two city councils.

RESPONSE: In 2019, a study of fire and emergency medical regionalization options in Thurston County was released. Subsequently, the cities of Olympia and Tumwater desired to explore the creation of a Regional Fire Authority to be formed within the boundaries of the two cities and to share the costs of the study of such an Authority. The cities formed a Regional Fire Authority Planning Committee consisting of three elected officials of each city as voting members. Further, each city appointed its Fire Chief (or their designee) and one union member chosen by each city's associated IAFF Local from its membership as non-voting members of the Planning Committee. Committee members served without compensation.

The Planning Committee was tasked with the following:

- A. Conduct its affairs and formulate a regional fire protection service authority plan as provided under RCW 52.26.040.
- B. Comply with the Open Public Meetings Act.
- C. Elect a Chair and Vice-Chair to preside at meetings and a secretary to record/post agendas, minutes, etc.
- D. Develop/approve rules and procedures for meetings (quorum, motions, Roberts Rules of Order, etc.)
- E. Develop and notice a meeting schedule.
- F. Create subcommittees to make recommendations.
- G. Select a consultant to facilitate and provide expertise in support of the Committee's work.
- H. Provide public information and conduct public outreach.
- I. Formulate recommendations on the formation of a Regional Fire Authority to the governing bodies of each city.

The Planning Committee was tasked with selecting a consultant (or consultants) to facilitate and provide expertise (financial, organizational, legal) in support of the Planning Committee's work. The consultant was selected by mutual agreement of the Planning Committee member. Tumwater, on behalf of the Parties, administered the contract with the consultant. Olympia and Tumwater agreed to evenly share the costs of the consultant(s) and any additional expenses. Tumwater would invoice Olympia for recovery of Olympia's share of expenses and Olympia would pay Tumwater invoices within sixty (60) days.

The Planning Committee was required to complete its work and formulate a recommendation to the governing bodies of Olympia and Tumwater within eighteen (18) months of the effective date of the Regional Fire Authority Interlocal Agreement (ILA). The ILA was effective when the last signatory executed the Agreement and remained in effect until December 31, 2022, unless sooner terminated. Any changes, modifications, or amendments had to be in writing and executed by each city. The ILA

was originally executed by Olympia City Manager, Steven J. Burney, and Tumwater Mayor Pete Kmet, on May 19, 2021.

On December 7, 2022, Olympia and Tumwater entered into a "First Amendment to Interlocal Agreement Regarding the Study of a Regional Fire Authority by the Cities of Olympia and Tumwater." The First Amendment recited that the Parties had made a recommendation at their November 14, 2022 meeting to their respective city councils to form a Regional Fire Authority and that the parties desired to continue their collaborative work and to amend the Regional Fire Authority Interlocal Agreement to continue such work by extending the term of the ILA to October 1, 2023. All other terms of the ILA remained in full force and effect.

A .pdf copy of the Regional Fire Authority Interlocal Agreement and a .pdf copy of the First Amendment to Interlocal Agreement Regarding the Study of a Regional Fire Authority by the Cities of Olympia and Tumwater are attached for your review.

• Who from the City of Olympia authorized the expenditure of City of Olympia funds to produce and distribute the Olympia-Tumwater Regional Fire Authority District (OTRFA) factsheet, and when was that decision made?

RESPONSE: The decision to send the informational mailer/factsheet was made by City Manager Jay Burney in March 2023.

• Who designed the factsheet, and who was responsible for the content? Please describe the factsheet approval and review process, and how the content of the factsheet was included.

RESPONSE: The "factsheet" or mailer was designed by Olympia staff. Steven J. Burney, City Manager, was responsible for final approval of the content. The factsheet/mailer was sent for review to Steven (Jay) Burney, Mark Barber, Kellie Braseth, Todd Carson, Ann Cook (Tumwater), and Brian Hurley (Tumwater). Text within the factsheet/mailer was provided by using Q&A information from the Regional Fire Authority webpage and information from staff presentation materials (Power Point) which was provided to the RFA Planning Committee during its consideration. Photos used in the informational mailer were stock pictures of firefighters and fire apparatus and did not identify the personnel as City of Olympia or City of Tumwater firefighters. The factsheet/mailer was for informational purposes only and not to support or oppose Proposition 1 and contained an express statement to that effect in the mailer.

• What was the City of Tumwater's involvement in the drafting of the content of the factsheet for the proposed creation of the Olympia-Tumwater Regional Fire Authority District?

RESPONSE: The drafting was the initial responsibility of the city of Olympia. Proofs of the factsheet/mailer were reviewed by Ann Cook, Tumwater Communications Manager, and Brian Hurley, Tumwater Fire Chief. Legal advice was provided to the respective staffs by Olympia City Attorney Mark Barber and Tumwater City Attorney Karen Kirkpatrick.

• Did the City of Tumwater send out the factsheet directly to their recipients, and was it the same factsheet as sent out by the City of Olympia?

RESPONSE: No. The factsheet/mailer was sent out by a vendor to all boxholders in the cities of Olympia and Tumwater. The same factsheet/mailer was sent to boxholders in Olympia and Tumwater.

• Did the City of Olympia or City of Tumwater staff produce and distribute the factsheet, or was an outside vendor or mail house used?

RESPONSE: No, as stated above, the cities of Olympia and Tumwater did not produce (print) or distribute the factsheet/mailer. An outside vendor was used.

• How much did the factsheet cost in total, and what was the City of Olympia and the City of Tumwater portions of the costs to produce and distribute the factsheet?

RESPONSE: Total cost for printing and mailing of factsheet/mailer: \$23,102.85. Postage/mailing: \$13,184.75. Printing: \$9,918.10. Olympia and Tumwater apportioned costs approximately two-thirds Olympia, and one-third Tumwater, based on the approximate number of boxholders in each jurisdiction.

• Concerning the City of Olympia and City of Tumwater recipients of the factsheet, was the factsheet sent to all households/boxholders?

RESPONSE: Yes.

• Did the City of Tumwater pay for their proportional costs of the factsheet directly or did they reimburse the City of Olympia?

INTERLOCAL AGREEMENT REGARDING THE STUDY OF A REGIONAL FIRE AUTHORITY BY THE CITIES OF OLYMPIA AND TUMWATER

WHEREAS, pursuant to RCW Chapter 39.34, local governmental units may enter into agreements on a basis of mutual advantage for the purpose of cooperating to provide services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population and other factors influencing the needs and development of local communities; and

WHEREAS, this Interlocal Agreement (hereafter Agreement) is made and entered into between and among the City of Olympia, hereafter referred to as "Olympia," and the City of Tumwater, hereafter referred to as "Tumwater," and collectively hereafter referred to as "Parties" or "the Parties;" and

WHEREAS, the service demands and costs of providing fire and emergency medical services have increased dramatically and disproportionally to other municipal services; and

WHEREAS, that cost escalation continues to put pressure on the limited resources of the Parties; and

WHEREAS, regionalization of fire and emergency medical services has been shown to deliver services effectively and efficiently to the community; and

WHEREAS, in 2019, a study of fire and emergency medical regionalization options in Thurston County was released; and

WHEREAS, Washington state law, RCW Chapter 52.26, provides an option for Regional Fire Authorities to be formed between cities for the purpose of providing regional fire and emergency medical services; and

WHEREAS, the Parties desire to explore the creation of a Regional Fire Authority to provide fire and emergency services within the boundaries of the two cities and to share the costs of the study of such Authority; and

WHEREAS, the Parties agree that a planning process that looks at the viability of an Authority will require input from affected groups, including represented employees, unrepresented employees, residents and businesses, other city departments, Medic One, and community partners;

NOW, THEREFORE, in consideration of the mutual promises contained herein, the Parties desire to enter into this Agreement as follows:

1. Pursuant to RCW 52.26.030, the Parties agree to form a Regional Fire Authority Planning Committee (hereafter "Committee"). The governing body of each Party shall appoint three (3) elected officials to the Committee as voting members. The Committee shall also include four (4) non-voting members. Each governing body shall appoint its Fire Chief (or their designee) and one member chosen by its associated IAFF Local from its membership. Committee members shall serve without compensation.

2. The Committee shall:

- A. Conduct its affairs and formulate a regional fire protection service authority plan as provided under RCW 52.26.040.
- B. Comply with the Open Public Meetings Act.
- C. Elect a Chair and Vice-Chair to preside at meetings and a Secretary to record/post agendas, minutes, etc.
- D. Develop/approve rules and procedures for meetings (quorum, motions, Roberts Rules of Order, etc.)
- E. Develop and notice a meeting schedule.
- F. Create subcommittees to make recommendations.
- G. Select a consultant to facilitate and provide expertise in support of the Committee's work.
- H. Provide public information and conduct public outreach.
- I. Formulate recommendations on the formation of a Regional Fire Authority to the governing bodies of the Parties.
- 3. The Committee shall select a consultant (or consultants) to facilitate and provide expertise (financial, organizational, legal) in support of the Committee's work. The consultant shall be selected by mutual agreement of the Committee members. Tumwater, on behalf of the Parties, will administer the contract with the consultant. The Parties agree to evenly share the costs of the consultant(s) and any additional expenses. Tumwater will invoice Olympia for recovery of Olympia's share of expenses and Olympia will pay Tumwater said invoices within sixty (60) days.
- 4. The Committee must complete its work and formulate a recommendation to the governing bodies of the Parties within eighteen (18) months of the effective date of this Agreement.

- 5. This Agreement shall be effective when the last signatory executes this Agreement, and shall remain in effect until December 31, 2022, unless terminated sooner pursuant to Section 6.
- 6. The Committee may dissolve itself at any time by a majority vote of the total membership of the Committee. Any Party may withdraw upon thirty (30) calendar days' written notice to the other Party. Notice shall be sent to:

- 7. No real or personal property is anticipated to be acquired by reason of entering into this Agreement. Should real or personal property be acquired during the term of this Agreement, the Parties shall work in good faith to determine the disposition of such property upon termination of this Agreement.
- 8. This Agreement shall be recorded with the Thurston County Auditor's Office or posted on the Parties' web site prior to being effective.
- 9. This Agreement may only be changed, modified, or amended by written agreement executed by both Parties.
- 10. By signing this Agreement, each signatory is certifying that they have authority to sign and that the necessary approval has been obtained from the legislative body of the entity represented by that signatory.

- C. Section 4 of the Agreement states the Committee must complete its work and formulate a recommendation to the governing bodies of the Parties within eighteen (18) months of the effective date of this Agreement; and
- D. Section 9 of the Agreement provided that the Agreement may only be changed, modified, or amended by written agreement executed by both Parties; and
- E. The Parties have accomplished significant progress by the Committee, having made a recommendation at their November 14, 2022 meeting to the respective city councils to form a Regional Fire Authority. The Parties desire to continue their collaborative work and to amend the subject Agreement by extending the term of the Agreement to October 1, 2023.

NOW, THEREFORE, the Parties agree to the following terms and conditions:

- 1. Term. Section 5 shall be amended to extend the term of the Agreement to October 1, 2023.
- 2. Full Force and Effect. All other terms and conditions of the Agreement not modified by this Amendment shall remain in full force and effect.

A JOINT RESOLUTION OF THE CITY OF OLYMPIA, WASHINGTON, AND THE CITY OF TUMWATER, WASHINGTON, TO FORM A REGIONAL FIRE PROTECTION AUTHORITY AND TO APPROVE A PLAN RELATED THERETO, AND PROVIDING FOR THE SUBMISSION TO QUALIFIED ELECTORS OF THE CITIES OF OLYMPIA AND TUMWATER, AT A SPECIAL ELECTION TO BE HELD ON APRIL 25, 2023, PURSUANT TO CHAPTER 52.26 OF THE REVISED CODE OF WASHINGTON, OF A BALLOT PROPOSITION TO APPROVE OR REJECT CREATION OF A REGIONAL FIRE PROTECTION SERVICE AUTHORITY AND A PLAN RELATED THERETO, WITHIN THE BOUNDARIES OF THE CITIES OF OLYMPIA AND TUMWATER, EFFECTIVE SEPTEMBER 25, 2023, TO BE FUNDED BY A PROPERTY TAX LEVY AND A NEW SIX-YEAR BENEFIT CHARGE

WHEREAS, the ability to respond to emergency situations by fire protection and emergency medical service agencies has not kept up or progressed with community needs, special service demands, and growing populations in the cities of Olympia and Tumwater (collectively the "Cities"); and

WHEREAS, a collaborative partnership and shared responsibility among local and regional governments and the private sector is better able to provide for an effective fire protection and emergency medical system than the Cities acting separately can provide; and

WHEREAS, the delivery of core emergency services and timely development of significant projects can best be achieved through the use of stable funding options provided for by state law for regional fire protection and emergency medical services; and

WHEREAS, the City of Olympia ("Olympia") and the City of Tumwater ("Tumwater") have had a cooperative partnership, striving to provide the highest level of fire and emergency medical services to their residents within the confines of available resources; and

WHEREAS, on May 19, 2021, Olympia and Tumwater entered into an interlocal agreement to study whether to form a regional fire authority. Subsequently, the Cities formed the Regional Fire Authority Planning Committee (hereafter "Planning Committee") to review the creation of a regional fire authority and associated service delivery and financing plan to provide fire protection and emergency medical services within the boundaries of the City of Olympia and the City of Tumwater. The members of the Planning Committee include three City of Olympia Councilmembers and three City of Tumwater Councilmembers. Also invited to the Planning Committee as *ex officio* non-voting members were Olympia Interim Fire Chief Todd Carson and Tumwater Fire Chief Brian Hurley, and union representatives of International Association of Firefighters (IAFF) Local 468, Steven Busz, and International Association of Firefighters (IAFF) Local 2409, James Osberg. The Planning Committee first

met on August 16, 2021, and recommended the creation of the "Olympia Tumwater Fire Authority," (hereafter "the Authority" or "Authority") and the adoption of an operations and finance plan to govern and finance the Authority's operation (hereafter the "Plan"). On November 14, 2022, the Planning Committee conducted a public hearing on creation of the Authority and the Plan. Following the public hearing, upon a motion duly made and seconded, the Planning Committee moved to recommend the formation of the Authority and its Plan to the Olympia City Council and Tumwater City Council. Copies of the Plan are available from the administrative offices of the City of Olympia and the City of Tumwater City Clerk; and

WHEREAS, the Cities are authorized to form a regional fire protection service authority by Chapter 52.26 RCW, which requires that in order to create a regional fire protection service authority, the formation of the Authority and its Plan must be approved by the voters of the area affected by the Plan. Therefore, in accordance with the Plan and state law, it is appropriate to place before voters within the proposed service boundaries of the regional fire authority, a ballot proposition for approval or rejection of the formation of the Olympia Tumwater Fire Authority, to be funded by existing property tax levy and a new six-year benefit charge, and the approval or rejection of the Plan for its governance, operation, and financing;

NOW, THEREFORE, THE OLYMPIA CITY COUNCIL AND THE TUMWATER CITY COUNCIL DO HEREBY JOINTLY RESOLVE as follows:

- 1. <u>Adoption of the Plan and the formation of the Olympia Tumwater Fire Authority.</u> The City Council of the City of Olympia, Washington, and the City Council of the City of Tumwater, Washington, hereby formally adopt the Plan and the formation of the Olympia Tumwater Fire Authority (hereafter "Authority"), a true and correct copy of which Plan is attached as Exhibit A to this Joint Resolution and incorporated by this reference.
- 2. Findings of the City Council of the City of Olympia, Washington, and the City Council of the City of Tumwater, Washington. The City Council of the City of Olympia, Washington, and the City Council of the City of Tumwater, Washington, hereby find that it is in the best interest of the City of Olympia and the City of Tumwater to submit to the qualified electors of the Cities of Olympia and Tumwater at a special election to be held on April 25, 2023, a proposition to approve or reject formation of the Olympia Tumwater Fire Authority and the Plan, which if approved will be funded by property tax not to exceed \$1.00 per \$1,000 of assessed value during such time as a benefit charge is collected, and not to exceed \$1.50 per \$1,000 of assessed value if the benefit charge is not being collected, and a six-year benefit charge not to exceed 60% of the Olympia Tumwater Fire Authority's operating budget. The dollar amount the Authority will levy in the first year in which the Authority imposes regular property taxes is \$1.00 per \$1,000 of assessed value. The estimated highest lawful levy for the City of Olympia, less the Authority's \$1.00 is \$8,172,083.06, and \$4,272,155.00 for the City of Tumwater. There is no change of amount of property tax levied to property owners. The Authority will impose a benefit charge of \$10,500,000.00 across the Authority's jurisdiction. If approved by 60% of the voters within the boundaries of the Authority as provided in Chapter 52.26 RCW, the Authority will be called the "Olympia Tumwater Fire Authority," with boundaries coextensive with the boundaries of the City of Olympia and the City of Tumwater, effective September 25, 2023.
- Submittal of Proposition to Voters. There shall be submitted to the qualified electors of the City of Olympia and the City of Tumwater for their approval or rejection, at a special election on April 25, 2023, the question of whether or not the Olympia Tumwater Fire Authority should be formed and

funded by existing property tax levy and a six-year benefit charge, and approval of the Plan related thereto. The City Council of the City of Olympia, Washington, and the City Council of the City of Tumwater, Washington, hereby request the Auditor of Thurston County, as *ex-officio* supervisor of elections to call such election and to submit the following proposition at such election, in the form of a ballot title substantially as follows:

PROPOSITION NO. 1

The City of Olympia and City of Tumwater adopted a Joint Resolution concerning formation of a regional fire authority and its Plan.

If approved, this proposition would form the Olympia Tumwater Fire Authority and adopt the Plan to provide fire protection and emergency medical services. The Authority will be funded by property tax (not to exceed \$1.00 per \$1,000 of assessed value) and a six-year benefit charge (not to exceed 60% of the Authority's operating budget). This funding would reduce Olympia's and Tumwater's property tax capacity by the tax rate collected by the Authority.

For the purposes of receiving notice of any matters related to the ballot title, as provided in RCW 29A.36.080, the City Council of the City of Olympia, and the City Council of the City of Tumwater, hereby designate Mark Barber, Olympia City Attorney, as the person to whom such notice shall be provided.

- 4. <u>Authorize Continued Acts of the Regional Fire Authority Planning Committee.</u> The City Council of the City of Olympia, Washington, and the City Council of the City of Tumwater, Washington, hereby authorize the Planning Committee described in the recitals of this resolution to continue operating on an as needed basis until the effective date of the Authority. The Planning Committee, for the purposes of RCW 52.26.230, shall conduct a public hearing on the benefit charge and file a report of the hearing with the county treasurer consistent with the requirements of RCW 52.26.230. The Planning Committee shall function as the governing board for the purposes of carrying out the requirements of Chapter 52.26 RCW until such time as a new governing board is established on September 25, 2023, pursuant to the Plan.
- 5. <u>Pro and Con Committee Appointments.</u> The City Council of the City of Olympia, Washington, and the City Council of the City of Tumwater, Washington, hereby assign to the Planning Committee the task of appointing members to a committee to advocate voters' approval of the proposition and to a committee to advocate voters' rejection of the proposition, as required by law.
- 6. <u>Severability</u>. If any section, subsection, paragraph, sentence, clause or phrase of this Joint Resolution is declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining portions of this resolution.

- 7. <u>Ratification.</u> Any act consistent with the authority and prior to the effective date of this Joint Resolution is hereby ratified and affirmed.
- 8. <u>Effective Date.</u> This Joint Resolution shall take effect and be in force immediately upon its adoption and passage.
- 9. <u>Triplicate Originals.</u> Three originals of this Joint Resolution are to be signed by the City of Olympia and the City of Tumwater.
