I recorded the contributions approved by contributors to the 2020 campaign to be transferred to the 2021 campaign as carryover funds. The PDC Filer Assistance Specialist has recommended that I wait until the PDC has implemented the new rules to be decided upon at its May 25 meeting and will advise me how to record these contributions. After I receive these instructions, I should be able to make the necessary changes within 10 business days.

Explain the discrepancy between the total amount reported of \$6960 on C4s #10013514 and #110019711 for your legislative campaign and the total amount reported of \$7860 on C4 #110015923 for your city council campaign.

The February 2021 C4 for the 2020 campaign reports surplus funds of \$6,115 transferred on Feb 10, 2021 and \$745 transferred on February 28, 2021, a total of \$6,860. The April 2021 C4 reports \$1,000 transferred on April 3, 2021. These transfers total \$7,860, the total shown on the C4 for the city council campaign.

What was the total dollar amount transferred between the legislative campaign and the city council campaign?

Did you obtain prior written authorization from contributors of your legislative campaign to transfer funds to your city council campaign? Please provide documentation that supports the approved authorizations corresponding to the amount transferred between the two campaigns.

Responses to Mr. Morgan's allegations:

<u>Failure to timely file Financial Disclosure documents</u>

The PDC has indicated that Mr. Zappone did file an F-1 report for the required period of 2019-2020 and has dismissed this allegation specific to that violation.

Failure to accurately report income/contribution data with the PDC

I recorded the contributions approved by contributors to the 2020 campaign to be transferred to the 2021 campaign as carryover funds, although they occurred in February and April 2023, because I could not locate any more specific guidance on how to record these transfers. The PDC Filer Assistance Specialist has recommended that I wait until the PDC has implemented the new rules to

be decided upon at its May 25 meeting (which should be clearer than previously) and will advise me how to record these contributions. After I receive these instructions, I will make the necessary changes and file amendments as needed.

The February 2021 C4 for the 2020 campaign reports surplus funds of \$6,115 transferred on Feb 10, 2021 and \$745 transferred on February 28, 2021, a total of \$6,860.
