To whom it may concern,

It has come to my attention that Poulsbo Councilmember Britt Livdahl has regularly violated Washington State's campaign finance laws (**RCW 42.17A**) for some time now. The violations are detailed as follows:

1) Repeated and extensive misuse of public resources to support her political campaign (Violation of RCW 42.17A.555)

It appears that Poulsbo Councilmember Britt Livdahl consistently and regularly misuses and misappropriates public resources in the City of Poulsbo to promote, support, fundraise, and launch her political campaigns, including the current one in which she is running for reelection for council position #3. I'll review the various examples I can find, but I'm sure they are not limited to just these examples.

Example#1 – Misuse of City issued email for political campaign.

See attached official screenshot of various websites where Britt Livdahl appears to regularly use her official city issued email as her political campaign email. This apparently has been going on for some time, and despite the training that this candidate has theoretically received to comply with the law, it appears that open and flagrant violation of the law, in addition to abusing the public trust is just a part of her political persona.

It is unclear so far how many campaign related emails she has sent or received at this address, but since it is reflected in all her campaign literature and public websites, it is clearly a problem.

Example#2 – Misuse of City address as campaign headquarters for political campaign

See attached official screenshot of Britt Livdahl's campaign which clearly shows her repeatedly using the City of Poulsbo's official mailing address as her main campaign address. This apparently includes the address where she would be presumably receiving contributions to her campaign. It is unclear how much City staff time and resources are utilized to process this incumbent politician's campaign contributions and campaign mail, but since city staff and resources are assigned to process this mail, it appears likely that this is more than just a small amount.

Example#3 – Misuse of City of Poulsbo official website to promote political campaign and fundraising links for political campaign

This is another egregious example of the misuse of public resources to support the fundraising efforts of this political candidate's campaign. See attached screenshot of the official City of Poulsbo website where Councilwoman Britt Livdahl's profile, includes (Under not-so-subtle campaign heading "Britt for Poulsbo 2023") a direct link to her political campaign website where supporters can make direct contributions to her political campaign.

Here is the address which can be linked directly from the City of Poulsbo website (at the time of this complaint): Britt for Poulsbo City Council Position 3-Britt for Poulsbo City Council

Weirdly enough, she also conveniently provides direct links to her personal business as well on this same public website, but this is more a violation of Washington State's Ethics Laws than it is a direct violation of Washington State's campaign finance laws. However, I only point this out to highlight the fact that it appears that once a politician decides to openly and flagrantly violate the law, they appear to be more likely to just violate all kinds of laws. More than a slippery slope argument, this is just further evidence and validation that something is exceptionally wrong with this politician's approach to her political campaign and misuse of public resources to promote her personal profit and political campaign.

A serious case can be made that the City of Poulsbo itself is also violating **RCW 42.17A.555** by using the publicly funded resources (website, email service, mail service, staff time, etc) to promote the Britt Livdahl campaign, but that would have to be determined by PDC staff as this is just the beginning of the trip down this misuse of public resources rabbit hole.

Let me know if you need any additional information on this one. I feel like I should have caught this one earlier, since these violations appear to be ongoing for years now.






