Candidate converted campaign from mini to full reporting on February 16, 2023 and still failed to file an F1 filing. To date the last F1 filing was for the period ending 2013, yes 2013.</p> <p>Violation of RCW42.17A.240  Candidate appears to be purposely hiding the source of a \$500.00 campaign donation. 4-28-2023 candidate has recorded a \$500.00 donation on report number: 110147050 as anonymous contribution with a Lynnwood address. The address identifies by property listing to Troy A Mitchell, a teacher.</p>
<b>What impact does the alleged violation(s) have on the public?</b>
Lack of transparency to voters. F1 filings are an important disclosure so that voters can identify where conflicts of interest. It appears candidate is intentionally attempting to hide a donor's identity.
