| <p><u>Glen Morgan</u> reported via the portal (Thu, 13 Jul 2023 at 7:31 PM) To whom it may concern,</p> <p>It has recently come to my attention that Lisa Brown, in her current campaign for the Mayor of Spokane, has violated Washington State's campaign finance laws (RCW 42.17A), once again. The details of these additional violations are as follows:</p> <p>1) Failure to file legally required 21 day pre-election report in a timely manner. (Violation of RCW 42.17A.235 & .240)</p> <p>Lisa Brown's campaign failed to file a 21 day pre-election report until 7/13/23, 2 days AFTER the deadline (See PDC Report #110159342 attached for reference). See news article which discusses some aspects of this campaign:</p> <p>https://www.ontheball509.com/news/primarytransparency</p> <p>Also, see report linked here:</p> <p>https://apollo.pdc.wa.gov/public/registrations/campaign-finance-report/110159342</p> <p>2) Illegal acceptance of over limit contribution from in-kind contributor (Violation of RCW 42.17A.405)</p> <p>Lisa Brown's campaign accepted an over limit contribution from an in-kind contributor (Hamilton Studio).</p> <p>This in-kind contribution was valued at \$2000 (at this time the applicable contribution limit was \$1000 per election). As the PDC has helpfully made crystal clear, In-kind contributions received before the primary may only be attributed to the primary and not the general election. Thus, Lisa Brown's campaign should be forced to refund this money (See PDC C4 Report #110141877 attached for reference)</p> <p>Also, see report linked here:</p> |

3) Illegal concealment of full mailing address of vendors who provided secretive in-kind contributions. (Violation of RCW 42.17A.235 & .240)

Lisa Brown's campaign has failed to provide the full mailing address of vendors where in-kind contributions were purchased from, as required by the PDC. The Brown campaign has reported six in-kind contributions and not a single one has this legally required information (See **PDC Report #110148819 attached** for just two of these examples). I will point out that this campaign has ample resources to comply with Washington State's campaign finance laws. There is no excuse to just blatantly, sloppily violate it will willful, egregious, purposeful attempts to conceal the truth like this.

The campaign reports who fronted the in-kind contribution, but they refuse to reveal where the in-kind campaign cash was spent. Specifically, I want to draw attention to the PDC's own website recommendations for how PACs and campaigns need to report this information. See original link here:

Specifically, I want to draw attention to the PDC's specific requirements of reporting:

"In-kind donations that are not incidental must be fully reported in Part 1 of Schedule B to the C-4 with the following details:

- ***the date the contribution was received;***
- ***the name and full address of the contributor;***
- ***if the in-kind contribution is a good or service purchased from a vendor, include the name and address of the vendor;***
- ***a brief description of the contribution;***
- ***its fair market value;***
- ***the cumulative total this contributor has given for the primary or general election, whichever applies;***
- ***a designation whether this contribution is for the primary or general election; and***
- ***if the contributor is an individual who has cumulatively given more than \$250 to the campaign, including both primary and general contributions, identify the individual's employer (by name, city and state) and occupation."***

This campaign must go back and report the truth and stop concealing it from the public, which appears to be an unfortunate pattern for this crew.

4) Illegal attempt to conceal debts from the public. (Violation of RCW 42.17A.235 & .240)

Additionally, in a continuation of this pattern of lawbreaking committed by this campaign, it appears that the Lisa Brown campaign has failed to properly disclose debts. **(See PDC Report #110141877 attached)**

Note the payment of \$10000 to Desautel Hege in March of 2023. The description given indicates that it is a first payment, which implies that the time the payment was made there was an additional balance outstanding. Despite this, no outstanding obligation was reported on the March C4.

Sure enough, the campaign would go on to make several more installment payments in April to the same vendor:

This further bolsters the idea that this was an unreported outstanding debt. There very well might be other unreported debts and financial obligations that the Lisa Brown campaign has failed to disclose.

5) Illegal efforts to conceal information from the public and hide the truth behind this campaign. (Another Violation of RCW 42.17A.235 & .240)

The records of Lisa Brown's campaign are littered with sloppy errors that have the practical and purposeful effect of misleading the public and concealing information. Here are just a few examples:

a) Contributor name "Andy Billing" (See **PDC C3 report #110141879** attached) Also linked here for staff reference:

The employer and occupation information indicates that this contributor is a legislator. There is no current legislator by that name.

b) PayPal vendor Address "San Jose, Washington" (See **PDC C4 report #110159185 attached**) and also linked here for staff reference:

It could be that the Lisa Brown campaign is attempting to turn Spokane into a city from California, but until they succeed in this political quest, there is currently no city known as San Jose in Washington State.

b) Failure to disclose quantity of yard signs. (See **PDC C4 report #110145916 attached**) and also linked here for staff reference:

The campaign purchased yard signs from Mountain Dog Sign Company and gave the description "sign approx 40" x 40"". Amount was for \$1,079.10. The quantity was not disclosed and it is difficult to believe that this was only for one sign considering it was over \$1000. Yard signs just don't cost that much even for a marginally managed campaign with lots of shady activity like this one. I will point out for the record, of course, that this is also a clear violation of **WAC 390-16-037 (see example B)**.

6) Willful attempt to conceal true sponsorship of campaign video (Violation of RCW 42.17A.320)

This video ad was required to have the full mailing address of the sponsor as part of the sponsor ID statement, but this was not included, of course. Seriously, does this campaign believe the law applies to them at all?

I have been gone for a long camping and hiking trip with my son for the last few weeks, which is why I haven't had a chance to catch the frequent flier violators like the Lisa Brown campaign. This was all I found in the few minutes I still have left at the airport and waiting for the endless security line to clear before I catch a plane home, but I'm sure I can find more violations if I spend a few more minutes looking closer.

I'll try to rectify my laziness soon. Until then, perhaps the PDC can convince this campaign that willfully and sloppily violating Washington State's campaign laws is not approved activity, even for a former cabinet appointee for the Inslee administration. The law is not intended to just be applied to the little people like the rest of us out here suffering the consequences of poor political leadership – it also should be applied to the people like Lisa Brown who apparently consider themselves above the law.

Let me know if you need more information on this campaign. I need to go catch a plane.
